WHY REBUILD ILLINOIS?

Rebuild Illinois will make a historic, bipartisan \$45 billion investment in creating good jobs, fixing Illinois' crumbling roads and bridges and building major projects that are essential to Illinois' future.

Every part of Illinois will see investment from Rebuild Illinois, which will put \$33.2 billion into our aging transportation system alone and support an estimated 540,000 jobs throughout the state. Rebuild Illinois addresses the unique assets and needs of each region of the state, ensuring Northern, Central, and Southern Illinois receive funding to begin to make significant infrastructure improvements and upgrades. As part of this plan, local governments will receive \$4 billion in transportation funds to meet their specific needs – their first increase in 20 years.

The Governor and bipartisan coalitions of lawmakers in the General Assembly came together to enact the Rebuild Illinois plan in a spirit of making the state stronger for generations to come.

METRO EAST PROJECTS



\$96 million for extending transit service from Scott Air Force Base to MidAmerica Airport.



\$24.4 million for a four-lane highway rerouting U.S. 67 to the east of Delhi, replacing two-lane rural road built in the 1940s that carries 11,000 vehicles a day.



\$55 million for construction of a new combined facility for the Illinois State Police.



\$105 million for construction of a Health Sciences Building at Southern Illinois University - Edwardsville.



\$37.5 million for renovation and repairs of the main complex at Lewis and Clark Community College.

STATEWIDE PROJECTS



Transportation - \$33.2 Billion

- ❑ \$25.3 billion in state, local, and federal funding will be directed towards roads and bridges.
- ❑ \$4.7 billion investment in mass transit throughout the state.



State Facilities - \$4.4 Billion

- ❑ \$35 million for capitol building renovations.
- ❑ \$4.0 billion in state facility deferred maintenance and new construction.



Education - \$3.5 Billion

- ❑ \$2.9 billion in funding for universities and community colleges.
- ❑ \$526 million in funding for preK-12 education maintenance and construction projects.



Economic and Community Development - \$1.8 Billion

- ❑ \$15 million for grants to minority owned businesses to help create a business ecosystem that will facilitate the growth and development of minority entrepreneurs and minority-owned enterprises.
- ❑ \$50 million for grants, loans, and other investments to emerging technology enterprises to foster economic development in Illinois.
- ❑ \$151 million for grants to museums, libraries, and art institutions.
- ❑ \$75 million for grants to companies to encourage new investments and expansions in economically depressed areas of Illinois.
- ❑ \$112 million for grants to educational and scientific facilities.
- ❑ \$1.4 billion for public infrastructure, community development, and economic development grants.



Environment/Conservation - \$1.0 Billion

- ❑ \$140 million for renewable energy upgrades to state facilities and grants related to transportation electrification infrastructure projects.
- ❑ \$31 million for flood mitigation projects to prevent flooding, rebuild deteriorated infrastructure, and encourage renewed economic development in communities.
- ❑ \$100 million for grants to unsewered communities to connect them to nearby publicly owned treatment facilities.
- ❑ \$75 million for Park and Recreational Facility Construction (PARC) projects to support park building construction and rehabilitation.
- ❑ \$22 million for state-owned dam and waterway projects to remove unnecessary dams and restore Illinois' rivers to more free-flowing channels.
- ❑ \$639 million for other programs at the Environmental Protection Agency and the Department of Natural Resources.



Healthcare and Human Services - \$465 Million

- ❑ \$200 million for construction and rehabilitation of affordable housing.
- ❑ \$50 million for community health center construction grants for capital improvements to new or existing sites.
- ❑ \$200 million for hospital and healthcare transformation grants to help low-income communities with high numbers of Medicaid patients to ensure Illinoisans have access to the medical care they need.
- ❑ \$15 million for a human services community development infrastructure grant program that focuses on upgrading facilities that provide a range of social services to vulnerable and special needs populations.



Broadband Deployment - \$420 Million

- ❑ \$20 million to enhance the Illinois Century Network, a high speed broadband network serving K-12 and higher education institutions, public libraries and museums, state and local governments, and broadband service providers.
- ❑ \$400 million for a broadband deployment grant program to expand access to reliable, high speed internet service statewide.
