This notice is to provide an update on the Emergency Procurement undertaken by the Capital Development Board for electrical system repairs at the Big Muddy Correctional Center.

On February 4, 2019 the Illinois Department of Corrections requested the Capital Development Board's assistance in seeking an emergency procurement for the expedited repair of the electrical system in the Residential Housing Unit #2 (R2) at Big Muddy Correctional Center. The electrical system in R2 had become noticeably faulty, which put the Department's operations in jeopardy.

There are 4 Residential Housing Units at this Correctional Center and each Unit consists of 4 WINGS (A thru D), and a Control Center Pod.

The time-line included the following:

In May 2018 the Department moved out approximately 50 offenders and eliminated the corresponding bed space from the C wing. In January 2019 the facility's maintenance staff noticed that the electrical current running to R2 was more than double the appropriate current. This led to the complete decommission of the unit's offender laundry capabilities.

This facility is home to approximately 1600 offenders and the workplace of nearly 350 staff. Furthermore, the facility is home to a specialized unit consisting of the Department's sexually dangerous persons. This is a highly specialized population that cannot be moved to another institution without a major risk to public safety. This specific population consists of approximately 170 offenders and the Department is mandated to provide a certain level of treatment by licensed staff and to be separated from the general population accordingly.

The Department of Corrections asked that CDB declare an emergency to repair the electrical system throughout the facility as soon as possible to prevent the threat to public health and safety, to minimize serious disruption in critical state services and to protect against further loss or damage to the facility.

Additionally, the Department of Corrections requested that CDB assess and repair the other 3 housing units as they were built at the same time as R2 and experiencing similar events.

This project began through the emergency selection of an Architect/Engineer ("A/E"); this exempts the selection from a 14-day solicitation required through Qualifications-Based Selection ("QBS").

Considering the time frames needed for the selection, negotiation and execution of A/E contracts followed by bidding and award procedures, electrical repairs at Big Muddy Correctional Center under the existing processes would likely not begin for several months. For this reason, emergency purchases were necessary to repair the electrical system as quickly as possible.

McCoy and Howard Consulting Engineers, Inc.(MHCE), was selected because of their familiarity with the facility, close proximity to the site, positive performance record with CDB and they could respond immediately to this request for emergency services.

If the assessments determine that work is also necessary in residential units R1, R3 and R4, and it is determined by CDB and the CPO that one or more of the additional residential housing units require an emergency declaration, they may be incorporated into this project in the future.

On April 9, 2019 a hearing was conducted to extend MHCE's contract until April 30, 2020. It was agreed that MHCE's assessment of R1 supported incorporating that unit into the project. This would provide DOC personnel flexibility when relocating inmates, if and when repairs to the electrical systems in R3 and R4 begin.

At that time it was anticipated that construction time to repair the electrical system in R1 would closely mirror the 6 months construction time experienced in renovating R2. As August 4, 2019 is the earliest date inmates can completely reoccupy R2, SPO Burlingham recommended extending MHCE's contract for 6 additional months beyond the requested end-date to allow the renovation of R1 to be completed, thereby establishing a new contract end date of April 30, 2020.

On May 17, 2019, the D wing of R3 experienced an electrical short on the lighting branch circuit conductor for the half of the second floor cells. Losing this branch circuit has caused DOC to relocate inmates in the affected area (15 cells) in order to meet safety and security guidelines for staff and inmates.

While investigating, facility electricians were able to find that the branch circuit wire had failed somewhere in the underground portion of the pathway since they had continuity on either side of where the underground raceway comes back up out of the ground. The wire feeding the lights had burned up under ground and the offenders in these cells had to be moved. This is a similar condition that forced DOC to empty R2-C wing and R1-D wing and led CDB to authorize the emergency repairs.

With this recent development, it is recommended to incorporate Residential Unit 3 (R3) into this emergency procurement to safeguard the welfare of DOC staff and the inmates.

Currently, MHCE's current Not to Exceed contract totals \$250,000.00 and is being paid on a Time and Material basis. A contract modification for additional compensation related to renovating the electrical system in R3 is not needed at this time.

UPDATE (08/19/19): On August 9th, 2019, Warden Sullivan expressed concerns regarding more frequent electrical issues in Residential Unit 4 (R4) and the effects a complete failure of the electrical system would have on the population of R4. R4 houses 347 Sexually Dangerous Persons (SDP), some of which require participation in various state mandated programs and therapy including but not limited to a Drug Treatment Program. Should a complete electrical failure occur, there are currently no available options for the transfer

this population. Since February of 2015, there has been a minimum of 21 events where branch circuits have failed, requiring IDOC to take action in the form of work orders. Currently, breakers are being tripped daily and exhaust fans in the A wing over cells 61 & 62 cannot be reset due to a dead short. Additionally, the conduit in pipe chases are visibly rusted to the extent that wiring is exposed. Given the failures in R1, R2 and R3, and the similar signs of failure in R4, it is in the best interest of the State to now incorporate R4 into this emergency procurement to protect against the threat to safety for the inmates and staff, and to prevent or minimize serious disruption in critical State services. Additionally, given the current vendors knowledge and expertise and the fact that they are already mobilized in the other Residential units, it is fiscally prudent to move forward with electrical repairs to R4.

Since the previous Extension Hearing held on April 9, 2019, the emergency declaration has expanded to include emergency electrical work in residential units R3 and R4. Currently, all work in R1 and R2 have been completed. The project team continues to work in R4 having completed Wings A, B and D. Remaining work includes R4 Wing C and POD and all of R3 and POD. CDB is requesting an emergency purchase extension through October 31, 2020 to allow for completion of the emergency work and close-out of the contract. CDB requires McCoy and Howard Engineers, Inc.'s continued participation to ensure proper documentation, observation during construction and assistance with Final Acceptance/Closeout of this project.

Notice of the hearing was posted to the Illinois Procurement Bulletin at least (14) days in advance of hearing and was also posted outside the hearing room no less than two business days prior to the hearing. The hearing was held to hear testimony and receive comments on extending the procurement.

Hearing Narrative:

An extension hearing was held remotely today via WebEx . Attendees were the PM, Marci Boudet; AE, Chip Fox with McCoy & Howard; CE, Todd DeJaynes; CDB Emergency Coordinator, Chris Miles; SPO Jerry Burlingham.

The PM gave a current status update. On Friday, March 20, 2020, the Department of Corrections in response to the National COVID-19 pandemic, directed the contractor and AE to all stop work, store unused materials on site, and demobilize from the facility. All corrective work in buildings R1 and R2 (Residential housing units) has been completed. Prior to this shut down, work in building R4, specifically in the 'C'-wing, the POD, and the Penthouse areas was underway and the anticipated date of completion was to be in April 2020. Additionally, in May 2019, repairs to Building R3 electrical system was incorporated into this emergency project, however work has yet to begin. Once work has restarted, the estimated completion time for building R3 remains at approximately 6 months as outlined when its inclusion was approved. McCoy and Howard Consulting Engineers' current contract end date is April 30,2020, and they are requesting to extend their contract an additional 6 months. At this time it is unknown how long the current suspension of work will last. Therefore, SPO Burlingham recommends McCoy and Howards' requested contract end date of October 31,2020 be extended until December 31,2020. The additional 60 days will hopefully provide relief of suspended work and provide additional time for re-mobilization and for work in buildings R3 and R4 to be completed. A re-start contract Modification is anticipated in the future as additional costs to the AE will be incurred. The estimated cost cannot be determined at this time.

The scope of work remains the same. Buildings R1, R2, R4 have all been completed. FW Electric moved into R3D and began demolition in September, 2020. Work crew sizes has been typically 4-5 and anticipated completion of R3D is end of October, 2020. Work remains in R3A, R3B, R3C, Penthouse, Pod. The estimated project schedule anticipates a completion of R3 in April-May 2021. COVID-19 work stoppages thus far have affected the schedule. In fact, due to precautionary measures, no work was performed at this location from March 20, 2020 through July 5, 2020 as a result of the COVID-19 pandemic and no work was performed from July 9, 2020 through July 27th, as a result of a positive COVID-19 test. Therefore, CDB is requesting an emergency purchase extension through May 31, 2021 to allow for completion of the emergency physical work and close-out of the contract. CDB requires McCoy and Howard Engineers, Inc.'s continued participation to ensure proper documentation, observation during construction and assistance with Final Acceptance/ Closeout of this project.

Electric personnel will begin working in the B & C wings of R3 as well as the Penthouse and Main Control Center Pod.

The PM and AE agree that all work should be completed by May 31, 2021 barring any further COVID or extreme winter weather delays.

Currently there is a NTE \$250,000.00 contract is in place. Current billings for the AE's design efforts is approximately \$66,000.00 so no additional AE contract Modifications are anticipated at this time.

SPO Burlingham recommends approval to extend McCoy and Howard's contract until May 31, 2021.

The scope of work remains the same. Buildings R1, R2, R4 have all been completed. Additionally, since the last Hearing, R3D is substantially complete and all punch list items have been complete. The project team was working in R3A when the project was again shut down as of November 6, 2020 as a result of COVID-19 positivity rates. Work remains in R3A, R3B, R3C, Pod & Penthouse. No work has been completed since November 2020 as IDOC has not authorized access to the facility. Therefore, CDB is requesting an emergency purchase extension through October 31, 2021 to allow for completion of the emergency physical work, once IDOC authorizes access, and close-out of the contract.
