Describe the scope of the emergency. Show justification for the need of an emergency contract, the selection of the vendor, and explain why the need for work cannot be met through a competitive process:

In preparation for patients that are receiving mental health treatment at Ludeman Developmental Center and Shapiro Developmental Center, who might potentially be diagnosed with Covid-19 or show similar symptoms, the Department of Human Services is requesting emergency purchases from CDB to assess and potentially renovate space in 4 homes at Ludeman Developmental Center and Building 603 at Shapiro Developmental Center for isolation rooms. This project began through an Emergency Selection of an Architect/Engineer ("A/E"); this exempts the selection from a 14-day solicitation required through Qualifications-Based Selection ("QBS"). Considering the time frames needed for the selection, negotiation and execution of an A/E contract, followed by bidding and award procedures if construction services are necessary, an assessment and/or renovation work at Ludeman Developmental Center and Shapiro Developmental Center under the existing processes would likely not begin for several months. For this reason, emergency purchases are necessary for Architect/Engineer services to assess, provide guidance and potentially design isolation rooms as quickly as possible in order to protect against the threat to public health and safety and to minimize a serious disruption in critical State services. Knight E/A, Inc., located in Chicago, IL was selected to provide architect/engineering services as they have the necessary experience for this work, are relatively in close proximity to the site and they can respond immediately to this request for emergency services.

Describe the scope of work or services provided to include special limitations, conditions and incorporated documents:

The scope of work provides for an assessment, guidance and potentially design services for the implementation of isolation space to meet the specific needs of the facility. Incorporated documents include the March 2009 Standard Documents for Construction & Supplement and the March 2009 Design and Construction Manual & Supplement. Services provided under this procurement should not exceed \$50,000.00, which is a place-holder prior to entering into a Professional Services Agreement, without prior authorization from the Capital Development Board in consultation with the Chief Procurement Office. Final Actual Costs will be reported upon project completion and project close-out.

Describe the scope of the original emergency (supply, service, etc.):

The original scope of work provided for an assessment, guidance and potentially design services for the implementation of isolation space to meet the specific needs of the facility. Isolation space was provide at Ludeman Developmental Center in Homes 4, 8, 33, 46 and 48, as well as Infirmary 62 which was inadvertently left out of the initial narrative. Isolation space was also provided at Shapiro Developmental Center in Building 603.

Describe the scope of the extension (supply, service, etc.). Show justification for extending the original emergency contract, and explain why the extension need cannot be met through a competitive process:

The scope of work remains the same. The project team has delivered 59 isolation rooms in six buildings at Ludeman and 106 isolation rooms at Shapiro in building 603.

At Shapiro, all temporary equipment was removed and replaced with permanent equipment including backup power as required by CDC guidelines. Nearing completion of the work, the Director of the facility expressed concern that residents were able to access ductwork and potentially pull it down from the ceiling. Therefore, additional work was asked of the project team to fasten down and/or move any mechanicals to protect the patients and staff from harm. Additional work included shortening the ductwork, moving mechanicals higher above the floor (above 7ft.), removing the HEPA filter units off the floors, and in 8 rooms removing the use of the window units, and moving the HEPA filter through the adjacent non used bathroom by placing a louver in the existing door. During the changes the electrical work was completed for total backup.

At Ludeman, temporary equipment, which included the installation of 6 Dedicated Outdoor Air Systems ("DOAS"), 6 diesel powered generators, and temporary duct work was provided on 04/18/2020. All temporary equipment was then removed and replacement with permanent equipment that included backup power as required by CDC guidelines. The permanent solutions were 95% complete as of 04/19/2020. This included providing 6 DOAS, 5 backup generators, connection for building 62 to existing backup power, 5 new gas lines, and meters from Nicor, 5 new primary, and secondary 3 phase power installed by ComEd along with other support equipment.

CDB requests an extension through September 30, 2020 to complete all remaining physical work, including any punch-list items, and to allow for complete close-out of the time and material contracts associated with this emergency project. CDB requires Knight A/E, Inc.'s continued participation to ensure proper documentation, observation during construction and assistance with Final Acceptance/ Closeout of this project.

The following individuals attended the Public Hearing: Andrea Bauer, CDB-Region1 Manager; Chris Miles, CDB Emergency Coordinator; Jeff Bedwell, Engineer, Knight E/A, Inc.; Becky Smith, CDB- Contract Executive;; Nosa Ehi, Owner, Bowa Construction; Leonard McGee, CDB-Project Manager; Ron Wright, CDB- Construction Administrator; and Ms. Erica (no last name given), a private citizen.

The PM provided a current status update: The AE is currently reviewing and validating contractor and subcontractor invoices, creating project close-out documentation, landscape restoration documentation, and final billing documents.

A MOD will be submitted in the near future to compensate the AE for additional design efforts for several items. They include the restoration of landscaping damaged by equipment and personnel in the process of work being performed; for ACM material testing services; for additional design efforts for temporary and permanent protection measures to protect residents from equipment on site, and for protection measures to prevent residents from tampering with the installed Direct Outside Air Supply (DOAS) units. The MOD will be for approximately \$50,000.00.

Ms. Erica (a private citizen) questioned the AE as to who authorized the design of negative air pressure rooms in a Dept. of Human Services facility as those facilities do not have infirmaries, or surgical suites and she could not locate any CDC guidance recommending their construction. Mr. Wright and the AE invited her to submit any questions to them and they would happily provide her the information and guidance authorizing this work.

All parties felt the additional time requested is reasonable and realistic to accomplish all outstanding tasks. SPO Burlingham concurs and recommends approval to extend Knight, E/A Inc's contract to September 30,2020

The project teams for both Ludeman and Shapiro continue to work toward completion of project close-out and continue to gather the needed backup documentation that each of the contractor's subcontractors, suppliers, and rental companies must provide in order to process accurate invoices. Invoice re-submittals and reviews have been made, however, documentation needed from several subcontractors, which also must be reviewed and approved by CDB Estimating, is delaying their ability to submit final invoicing. The project team for Shapiro feels another sixty (60) day time extension will be needed for the contractor to allow time for proper reviews, responses and final invoicing. The project team for Ludeman feels another (90) day time extension will be needed to allow time for proper reviews, responses and final invoicing. Therefore, CDB feels it is prudent to consider extending the A/E's emergency declaration through November 30, 2021 to allow additional time to close-out the contractor's time and material contract, followed by close-out of the A/E contract. CDB requires Knight A/E, Inc.'s continued participation to ensure proper documentation, and assistance with Final Acceptance/Closeout of this project.

Term of emergency procurement shall not exceed 90 days. Contract may be extended beyond 90 days if CPO determines additional time is necessary; however, prior to execution of extension, CPO must hold a public hearing and provide written description

Notice of the hearing was posted to the Illinois Procurement Bulletin at least (14) days in advance of hearing and was also posted outside the hearing room no less than two business days prior to the hearing. The hearing was held to hear testimony and receive comments on extending the procurement.

Hearing Narrative:

Project Manager Steve Halm provided a brief status update regarding a pending contract modification (Mod) to the AE for landscaping design services.

This was presented in multiple previous extension hearings as well, and as of this date, the Mod has yet to be submitted to the CPO for review.

In short, no new information was presented. The need for the AE to review outstanding contractor invoices that may be presented in the future was the sole argument for extension.

It was again confirmed that all physical work has been completed since August 2020.

It was again confirmed that if the contract is allowed to expire, that invoices presented will be accepted by CDB-Fiscal and the State Comptroller when the cited dates of work are prior to July 31, 2021.

The AE has requested their contract be extended for another 122 days to November 30, 2021.

This is the 6th extension request.

Assurances made in multiple past hearings have not been fulfilled have made little to no impact in achieving project close-out.

As a courtesy, request consideration to provide the AE a final contract extension not to exceed an additional 91 days, establishing a final contract end date of October 30, 2021.
