Describe the scope of the emergency. Show justification for the need of an emergency contract, the selection of the vendor, and explain why the need for work cannot be met through a competitive process:

On December 1, 2018, a tornado occurred in the Beardstown area resulting in substantial damage to the Beardstown Readiness Center. The damage includes but is not limited to missing roof deck and membrane, the destruction of multiple HVAC roof-top units, multiple blown out windows, a blown down motor pool fence, structural issues with storage building(s), interior water/wind damage to ceilings and carpet, and ripped out roof vents in the bathroom/locker rooms. The Department of Military Affairs (DMA) has procured a contractor to provide immediate temporary repairs to the roof as well as a contractor to winterize the plumbing systems to prevent freeze damage. DMA has asked that CDB procure an Architect-Engineer to assess the damage to the facility, determine what is salvageable and provide design services as needed. This project began through the emergency selection of an Architect/Engineer ("A/E"); this exempts the selection from a 14-day solicitation required through Qualifications-Based Selection ("QBS"). Considering the time frames needed for the selection, negotiation and execution of an A/E contract, the assessment of the Beardstown Armory under the existing processes would likely not begin for several months. For this reason, emergency purchases are necessary to protect against the threat to public health and safety, to protect against further loss and damage to the facility, and to prevent or minimize serious disruption in critical State services. Charles Joseph Pell Architects, Inc. was selected because they have experience with DMA projects and have the necessary discipline to complete the work, are in close proximity to the site and can respond immediately. Hearing Narrative:

The scope of the extension provides for design documents and construction administration of the repair work at the Beardstown Armory as outlined in the Assessment of Storm Damage report dated December 26, 2018, to include any additional damage found after the report was issued. The assessment outlines multiple areas of the building has suffered structural damage, to include the need for MEP repairs and replacements and extensive roof repairs. CDB is requesting an emergency purchase extension through September 30, 2020 to allow for design, normal construction bidding processes, completion of the work and close-out of the project. CDB requires Joseph Pell Architects, Inc.'s continued participation to provide design and observation services for all repair work, as they are familiar with the site, scope of work, and can continue to work in an expedited manner to allow for the facility to be occupied as quickly as possible. Additional fees will be applicable for any A/E design and construction efforts. The Illinois Department of Military Affairs is currently attempting to capture funding from National Guard Bureau to assist in funding this emergency project. SPO Burlingham recommends extending Charles Joseph Pell Architects contract to September 30, 2020. This will allow for the design, bidding, and construction processes to be completed and to align any funding challenges with the Illinois National Guard and Department of Defense fiscal year end.

Installation is going to cause additional drywall repair, finishing, and painting, but these costs will be absorbed by Johnco. Currently, one proceed order is pending with Johnco, and it is for additional fence repairs where DMA's project manager noted the fencing would not pass DMA's security inspection. No additional contract modifications are anticipated for the AE. This project was stopped on or around March 19, 2020 as a result of the COVID-19 pandemic and resulting shelter in place orders and there were difficulties finding the required tradespeople once the project re-started. Additionally, the project was initially delayed for over two months as a result of a bid protest. Due to the delays caused by the COVID-19 pandemic, and bid protest, CDB is requesting an emergency purchase extension through December 31, 2020 to allow for the completion of all physical work and formal close-out of the project. There are multiple Change Orders yet to be submitted for review/approval where the AE's review and concurrence is required. The use of Alternative Dispute Resolution may be required to resolve a claim regarding structural crack filling. CDB requires Joseph Pell Architects, Inc.'s continued participation to provide close-out assistance, as they are familiar with the site and scope of work completed.

Additionally, the contractor, Johnco Construction will be entering Alternative Dispute Resolution (ADR) mediation to resolve differences of interpretation with the project specifications. Specifically, to claim structural crack filling on the building is additional scope.

CDB- Legal has been advised but a mediation date has yet to be established.

CDB requires Joseph Pell Architects, Inc.'s continued participation to provide close-out assistance, as they are familiar with the site and the remaining documentation to be completed.

CDB requested an emergency purchase extension through May 31, 2021 to allow for the review of the two outstanding Change Orders, and any potential Change Orders resulting from the mediation in addition to the normal project close-out processes.

Charles J. Pell Architects current contract amount is \$155,202.00. No additional contract modifications are anticipated at this time.

Without an established mediation date, SPO Burlingham recommended extending the AE's contract an additional 60 days to allow for the submission of the two outstanding Change Orders and for the mediation to be resolved. All in attendance agreed.
