The Illinois Angel Investment Tax Credit Program officially became effective on January 1, 2011. The purpose of the Angel Investment Program is to attract and encourage the placement of investment dollars into early-stage, innovative companies throughout Illinois. The investment dollars provide these companies with much needed access to working capital to further their growth and success in our State.

I. Introduction

The Illinois Angel Investment Credit Program ('Program') is designed to encourage interested firms or individuals to make an investment in one of Illinois' innovative, qualified new business ventures. The investment will encourage job growth and expand capital investment in Illinois. The Program can offer a tax credit, to qualified investors, in an amount equal to 25% of the investment made directly in a qualified new business venture. The maximum amount of tax credits to be issued under the Act is capped at \$10,000,000 per calendar year. The Program was administered for the taxable years beginning after December 31, 2010 and ends on or before December 31, 2016.

The Program has two components of participation: (i) a business component and (ii) an investor component. Interested Illinois businesses must apply to DCEO each taxable year for which the business desires registration. If deemed eligible, the business can direct investors to apply for a tax credit. Investors of eligible businesses must submit an application to DCEO in order to be considered for a tax credit. To receive a credit, investors must (i) invest in the eligible business after the business has been deemed eligible, (ii) submit an executed application (which conforms to the Program's requirements) and (iii) certify to keep their investment in the qualified new business venture for no less than 3 years.

Effectiveness:

In only its fourth year of existence, the Program has aided in the placement of more than \$128 million in investments into early-stage, innovative businesses throughout Illinois. This figure represents the investment necessary to generate just over \$32 million of total tax credits issued since the inception of the program.

In 2011, the Program utilized just \$2,044,085.83 of the available \$10 million in tax credits and those credits had been awarded to 65 applicants. The first year of the Program created a great deal of interest with new innovative businesses, searching for the ideal business friendly climate to locate, and professional investors, investing in similar programs in other states. During the first year, the Program contributed to over \$22 million of capital investment into the State of Illinois.

In 2012, ninety nine businesses registered with the Program. Of those ninety nine businesses, forty eight received investment dollars. Moreover, the Program utilized all \$10 million of available tax credits by just over four hundred investors. In 2013, the Program, again, utilized all \$10 million of available tax credits and those credits had been issued to three hundred and seventy four investors. An additional one hundred and nine businesses registered in the Program and forty six businesses became qualified. Since the inception, the Program has been a key resources for creating much needed capital in Illinois start-up businesses.

II. Claimant Information
