Cedarville's project is for the construction of storm sewer improvements that entails approximately 925 lf of storm sewer piping, along with grading and shaping earthwork and associated roadway repair to properly manage the excessive storm drainage that is impacting area residents. The project includes storm sewer along the 200 block of Washington Street, Mill Street, Cedar Street and inlets with curb and gutter at the end of the cul-de-sac on Oak Ridge Drive. The Village of Cedarville is located in Stephenson County in Northwest Illinois.

REQUEST FOR RELEASE OF FUNDS

On or about May 31, 2016 the Village of Cedarville will submit a request to the Illinois Department of Commerce and Economic Opportunity for the release of Community Development Block Grant funds under Section 104(h) of the Housing and Community Development Act, to undertake a project known as Storm Drainage Project for the purpose of storm sewer improvements at two locations within the community, estimated funding is \$207,332 from the CDBG Grant with approximately \$72,048 in Village Funds with the project located at Oak Ridge Street, Cedar Street and Washington Street in Cedarville, Illinois.

FINDING OF NO SIGNIFICANT IMPACT

The Village of Cedarville has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. 11. Program Activity/Project Description

In order to meet the conditions of the new NPDES Permit, the Village must retrofit disinfection equipment back into the wastewater treatment facility owned and operated by the Village of Chapin, Morgan County, Illinois. The wastewater treatment facility is located at 901 Catalpa Street, Chapin, Illinois. The new project will include the installation of chemical feed equipment into an existing on-site CMU building, installing 1/2" diameter chemical feed lines to and from a new 4' diameter manhole adjacent to an existing manhole. All of the construction will occur within the confines of the existing wastewater treatment facility property which was previously disturbed by the original construction. The approximate costs of the project are \$125,458 of which \$94,093 will be funded by State of Illinois CDBG-PI funding and \$31,365 from Village sewer funds. The proposed timeline is to post FONSI/NOI/RROF May 2016, Clear Special Grant Conditions/DCEO Funds Released July 2016, Advertise for Bids August 2016, Open Bids, Award Contract and Issue Notice To Proceed September 2016 and complete construction by March 2017.
