SECTION II. WATER TEMPERATURE

Rule 402.8(e) If the foster family home accepts children under the age of ten or who are developmentally disabled, the maximum hot water temperature from all showers and bathtubs shall be no more than 115° Fahrenheit.

Rule 402.8(m) Any and all firearms and ammunition shall be stored and locked up separately at all times and kept in places inaccessible to children. No firearms possessed in violation of a State or federal law or a local government ordinance shall be present in the home at any time. Loaded guns shall not be kept in a foster home unless required by law enforcement officers and in accordance with their law enforcement agency's safety procedures.

I certify that there are no firearms on the premises, but will immediately notify the Licensing Representative and complete form **CFS 452-2, Foster Family Firearms Arrangement**, if I, or any member of the foster family home, acquires a firearm.
