#### **Understanding the Licensing Data report:**

**LICENSING AGENT -** A department or private agency licensing worker who is responsible for making a particular licensing recommendation/decision.

**LICENSED** - The number of facilities that have a current license. In most cases, licenses are valid for a four-year period, after which a renewal of the license is required.

EXPIRED / RENEWAL - The number of facilities where the current license has expired and the renewal is in process.

**CAPACITY** - The number of children a facility is entitled to serve as determined by the licensing worker.

**EXPIRED** - The number of facilities where the current license has expired and a renewal license has not been yet issued.

**PENDING** - The number of new facilities currently under study for a license. The count does not include facilities requesting a renewal of an existing license.

**Note:** Licensing information provided is non-duplicated, point-in-time data based on information available on the last day of the reporting period.
