- Org Chart (DCFS) Keith
 - Keith Polan was confirmed as Chief Deputy of Child & Clinical Services on 5/23/22.
 Jacqui Dortch has taken the role of Deputy Director of Child Services. Alicia Ozier has resigned as the Deputy Director of Clinical



- Background Check Update Licensing
 - Conditional background checks are continuing until further notice. A committee with private agencies is being put together to streamline the process; Jassen Strokosch requested agencies provide names of individuals to be a part of the committee. A letter will be distributed to agencies (date to be determined by Shante Blankenship) regarding the use of conditional background checks.
 - Next Steps
 - 5/25/22: Gwendolyn Payton will touch base with Shante regarding letter progress
 - 5/27/22: Ashley will send categorized questions (from Providers) regarding conditional background checks and process
- FY23 Contracts Keith
 - Family First language will be added to contracts shortly
 - Edited Matching Checklist Keith and Linda Karfs are working on this. The updated checklist will also align with the work in Jacqui's division, to quickly identify placements and not make inappropriate matches
- Child Services Jacqui Dortch
 - 4 Clinical Placement Managers started throughout the state; 1 per region
 - Kimberly Newsome: Southern region
 - Karen Austin-Antoine: Cook region
 - Omesha Redding: Central region
 - Mary Ford: Northern region
 - Expansions are happening across the division: Juvenile Justice and Human Trafficking are expanding programming; Resource & Recruitment is expanding their resources; Residential Recruiters are bringing new providers on board
 - TLP Project Initiative targeting 68 youth needing TLP placements. 25 youth have been confirmed for stepdown. Initiative began February 2022 and is projected to end 6/30/22, to accommodate youth that are waiting to finish school. The process includes: Ryan Goodwin sending packets to providers and following up with phone calls (multiple times if necessary). A provider meeting was also held to answer questions. The focus has been on revealing and utilizing existing capacity while streamlining the process
