 - c. DCFS Work From Home Survey— it was issued and 1000+ people with results are being tabulated
 - d. COVID vaccine for 16 yr olds it is being looked at
- **3.** Family First (FFPSA) through the system of care principles and community impact, brief updates and EBI pilots IV-E in impact related to system of care. Follow-up from Jennifer's presentation.
 - a. Referrals some agencies are struggling, while others have waiting lists. Talk of expansion down the road in FY23, once providers have a full year of solid service
 - b. Medicaid it is in the contracts to get the language right, but won't be implemented until FY23
 - c. Invite Dr. Mann to next meeting regarding where FFPSA is missioned to go, as well as in terms of prevention
- 4. **Managed Care Organizations:** YouthCare updates and progress (updates from Brenita Johnson on behalf of Shawnte Alexander) YouthCare "crisis support" with MCR/SASS
 - a. Per Brenita, a new team was created called CSMDT headed by Trinika Michaels. She can be invited to the next meeting to provide an overview and update
 - Per Stephanie B, concept is to pull team together quickly (within 24 hours) when a Youth in Care is in need of hospitalization and a provider cannot be found. Mobile crisis is called in to figure out a plan. CSMDT is also used in situations where the youth is not stabilizing

- Process for Mobile Crisis initiation: Register on "CSMDT" Portal and log in, click mobile crisis and submit youth's name and synopsis, securely

 - b. Stephanie shared flyer with this group
- b. Any MCOs updates on the IM-CANS? No update
- 5. **Medicaid, Integrated Health Homes (IHH) and 1915i** (Kristine Herman from HFS, ICOY and CBHA)—no updates. Kristine delayed by another meeting/
 - a. IMCANS/CANs 2.0 issues—no updates
 - b. **1915i** what is the impact on the child welfare system and initial feedback from the group as it relates to DCFS
