- 1. Approve minutes from previous meeting Merry Beth Sheets approved minutes, Michelle Churchey-Mims seconded
- 2. Update and topics from CWAC and other Sub-committee meetings
 - a. Large CWAC meeting provided information about SAFE Model (Ashley Deckert will send slideshow presentation). There was also an update about background checks; a resolution is scheduled for January 2023, a portal is being developed with logistics to follow, and DCFS is also working with Accurate Biometrics to speed up the process with a hope of implementation in Fall
- 3. Update on Family First (FFPSA) through the system of care principles and community impact
 - a. Dr. Kimberly Mann's position is still vacant

5. 1915i/Pathways to Success/NB Consent Decree

- a. Kristine Herman, HFS
- b. Feedback on the DCFS communication materials provided to the group by Michelle Moreno: Pathways to Success Townhall – it will be open to all DCFS users – everyone with a "Illinois.gov" email. HFS & DCFS will both present
 - a. There needs to be a workaround for those individuals who do not have an "Illinois.gov" email address. Options are to open it up to another email list, have individuals forward the email, and place in ICOY newsletter
 - Access there needs to be a platform for people to learn/access information/systems. Examples of information/access needs include: accessing databases of information, accessing IMCANS2.0, completing IM+CANS, accessing Pathways from a CARES line, talking about Medicaid specific providers as opposed to being specific to the category

- c. Add a DCFS qualifier to the definition
- d. Eligibility Criteria: #3 "Have a Serious Emotional Disturbance (SED) or Serious Mental Illness (SMI)", may not be understood. It sold be combined with #4 "Demonstrate a need for intensive services based on the IM+CANS)
- e. Maintain SASS language
- f. Care Coordination & Support Organizations slide May want to remove some language because Care Coordination can be provided by someone different than the crisis response, which can cause confusion
 - 1. Clarify that this is for Intact & Permanency youth
 - 2. Note that the training is in high fidelity wraparound ad intensive care coordination
- g. Care Coordination...Tier 1 & Tier 2 Define the CFTM: who is involved, how do they get started, notating that there is only one CFTM per child
- h. Family Peer, Respite, Mentoring, Intensive, Therapeutic, Individual
 - 1. Family peer support make "caregiver" plural
 - 2. Respite "scheduled" with a "d". Flush out what child welfare respite looks at as opposed to Pathways definition
 - 3. User friendly language
 - 4. Care Coordinators specify that this will happen within the CFTM
