Paul Hamann reviewed Task Force purpose.

Introduction of newly confirmed member Hillary Hines-Holl who fills the Defense Attorney role.

VI. Update on Rules of Procedures Bylaws revisions

Task Force discussed the revisions to the Bylaws. Generally, the group aims to capture the intent of the Task Force and take care not to be too specific but rather capture the intent and allow for flexibility.

Highlights:

- Medical and Mental Health should be separate providers
- There should be a Child Abuse Pediatrician, Health Professionals (PA, Nurse Practitioners, etc.). Only 14 Child Abuse Pediatricians in Illinois and several are retiring.

- Mental Health Primary responsibility is child abuse cases, allow for detail.
- Domestic Violence connection in the current child abuse cases.
- Intersectionality of domestic violence, substance abuse and mental illness should be considered.
- Specific CACs should not be named.
- GAL Distinction between GAL and Attorneys/ GAL preference to be an attorney with significant experience with Juvenile court.

Action Item: Invite a Guest speaker on DV and its intersection to Child Abuse and how does DCFS handle domestic violence. Mary Stein and Chantelle Porter may be able to find someone.

Action Item: Draft Rules of Procedure to vote on at next meeting. At least 7 days prior to next meeting. February 2nd. Next meeting is 2/9.

VII. Diversity Ad Hoc Committee Update – Kim Mangiarancino

Kim presented on the CJTF Member Matrix to capture our data.

Danielle Fischer – Is the DEI lead.

Include the categories that DCFS tracks/considers.

Privacy concerns – records, are they reportable.
