CAC not just a place for child interview but also as a MDT. Obstacles – turn over, lack of communication, poor investigations. Medical Triage of hotline calls.

Recommendations due by end of March — Decision points, earlier involvement with medical professionals earlier (hotline). Tamala. Tierney, Jason to meet to see how the task force can assist/provide recommendations.
