The Native American Employment Plan – decision was made by CMS Central Management System. Jassen advise to get a direct answer would be a question for CMS.

The two Positions were original posted Mid-February on Feb 18th, 2021. Application Deadline March 19, 2021. The next step is start the interview process. DCFS was unable to share when the potential start date for the 2 positions.

ICWA council had to find out by the native american community and not within this group. ICWA council should be notified directly about these issues. They had no prior knowledge either of these changes. Doug apologizes on their behalf and not sharing sooner when they were notified due to staff change and fell between the cracks on notifying ICWA council sooner. CMS let the Native American group sooner because they had a meeting following with the group. This group is priority of Information over any other groups. Tracey will be a resource and Kara Hamilton.

O ICWA Budget FY 20 & FY 21. ICWA council request to be provided the budget for these fiscal years. As last year budget was \$309,000 Council inquired about the budget for the fiscal year 2022. Does this budget allocate a line item for professional development and increase foster homes for Native American children in care?
