DCFS Updates – Daniel Fitzgerald, Chief of Office of Affirmative Action

- ICWA Specialist Positions Two positions starting September 7, 2021
- Follow up on Training Funds Approved for Sandy Whitehawk Daniel said that we are waiting for training until the two ICWA specialists start their positions. Is it a 30 or 60 day window to get this training paid for? What is the timeline to request funds for the ICWA training to be paid through DCFS? Kara will check in on that.
