- A. DCFS Legislative Updates Megan Jorgensen not able to attend meeting, Lindsay provided update from her email- there have been no movements and no updates. The legislature has not met since June and they have no plans to meet at this point. They will potentially resume in January, but that will be a "new session," and all legislation from this current session will die.
- B. Committee Membership-Update Dr. Dabrowski fax was sent to pediatrician; Vea will follow up with possible replacement for Judge Martin with a phone call
- C. Training
  - Mandatory Training Update (Ethics, Harassment and Discrimination Prevention)
     Questions around whether training is tracked by calendar year or fiscal year; Lindsay will follow up with Ethics Officer to confirm training timeline
  - ii. CRC Speaker Child Death Review Team Update- Vea will be in contact with CDR chair to see if someone can join a SCAN meeting to provide insight into what other groups are working on
- D. SCR/Hotline Presentation Trista Cox, Assistant Administrator of the State Central Register Child Abuse Neglect/Hotline provided presentation to SCAN committee. The main office is in Springfield on Churchill Dr. and some expansion has taken place to include SCR staff in Chicago and East St Louis (increased bilingual staff). 268,000 calls in last year, 47% resulted in intake. Online Reporting System was revamped in September of 2020; not for urgent situations; anyone can use system. Schools are the #1 reporters, then law enforcement and medical personnel. Email has to be used for online reporting, but can be anonymous.
