- Basic knowledge and information on the allegation system and the process of a child coming into care would be helpful for those that have zero knowledge. A basic overview of Procedure 300, the Mandated Reporter Book.

- Discuss ways to protect children from being placed in foster care due to incarceration by parent.
- Invite group from HB2914 to meeting to discuss the discriminatory practices they are finding.
