ENVIRONMENTAL REVIEWS COMPLETED

Project reviews completed from June 16 to July 15 are listed below. These projects have been screened through the internal environmental review process for potential impacts on wetlands, threatened and endangered species, and cultural and archaeological resources, etc. Through the review process it was determined that environmental impacts have been kept to a minimum and mitigated as necessary, that they do not meet the criteria for significant actions as defined in the environmental review process, and may proceed. All these projects are in compliance with the Endangered Species Protection Act, Natural Areas Preservation Act, Interagency Wetlands Policy Act and cultural resource statutes.

- **Illinois Beach State Park**

2111339—This project involves offshore breakwater construction and beach nourishment of sand to offset shoreline erosion at the site. Project most recently submitted for review on 3-10-2021.

- **Sangchris Lake State Park**

2113220—This project involves construction of a parking lot at the Strawkus Point day use fishing area. Project originally submitted for review on 4-28-2021.

- **Rend Lake**

2106953—This project will create a wetland for independently managed waterfowl. Project originally submitted for review on 10-16-2020.

- **I&M Canal at Marseilles**

2113020—This project will permit a landlocked neighbor to build and maintain a gravel access drive across Canal property. Project originally submitted for review on 4-23-2021.

- **Pullman National Monument State Historic Site**

2003089—This project will renovate and repair the North Factory Building. Project originally submitted for review on 9-24-2019.

- **Channahon State Park**

2114834—This project will re-paint the historic Locktender's House. Project originally submitted for review on 6-15-2021.

- **Black Crown Marsh**

2113153—This project will remove invasive and opportunistic woody species to help maintain natural vegetation. Project originally submitted for review on 4-27-2021.

- **Giant City State Park**

2115108—This project will install two park benches at the site. Project originally submitted for review on 6-24-2021.

- **Donnelley State Fish and Wildlife Area, Coleman Lake**

2112744—This project will replace the existing, non-functional water control structure at Coleman Lake. Project originally submitted for review on 4-19-2021.

- **Sangchris Lake State Park**

2112906—This project proposes to repair the existing sub-impoundment levee. Project originally submitted for review on 4-21-2021.

- **Chain O'Lakes State Park**

2200084—This project installed waterlines for the horse pasture at the farm lease on site. Project originally submitted for review on 7-02-2021.

- **Anderson Lake State Fish and Wildlife Area, Carlson Lake**

2113500—This project will construct a designed overflow embankment section to reinforce the outlet structure. Project originally submitted for review on 5-07-2021.

- **Pullman State Historic Site**

2200370—This project will permit masonry stabilization repairs at the Rear Erecting Shops. Project originally submitted for review on 7-09-2021.
