## ENVIRONMENTAL REVIEWS COMPLETED

Project reviews completed from October 15 to November 15 are listed below. These projects have been screened through the internal environmental review process for potential impacts on wetlands, threatened and endangered species, and cultural and archaeological resources, etc. Through the review process it was determined that environmental impacts have been kept to a minimum and mitigated as necessary, that they do not meet the criteria for significant actions as defined in the environmental review process, and may proceed. All of these projects are in compliance with the Endangered Species Protection Act, Natural Areas Preservation Act, Interagency Wetlands Policy Act and cultural resource statutes.

- **Johnson Sauk Trail State Park**

1406030 - This project involves replacing two metal pipe drains under the park road with two larger corrugated metal pipes and removing the drop box inlet structures. Project was submitted for review on 11-13-13.

- **North Point Marina**

1405930 - This project involves construction of a pavilion at North Point Marina. Project was submitted for review on 11-8-13.

- **Illinois Beach State Park**

1405617 - This project involves restoration of the chimney and fireplace in the Custodian's Quarters at Camp Logan National Guard Rifle Range Historic District with Illinois Beach State Park. Project was submitted for review on 10-25-13.

- **Johnson Sauk Trail State Park**

1405193 – This project involves converting the existing site residence into the site superintendent office. Project was submitted for review on 10-8-13.

- **Randolph County State Recreation Area**

1405342 - This project involves replacement of a metal culvert and 240 feet of polyethylene pipe, which is located under the boat parking lot and septic drainage field. Project was submitted for review on 10-15-13.

- **Cache River State Natural Area**

1402166 - This project involves demolition of a residence that came with the purchase of the Owen's property at the Cache River. Project was submitted for review on 8-1-13.

- **Green River State Wildlife Area**

1405446 - This project involves clearing approximately 100 acres of invasive woody vegetation with a hydro-axe. Project was submitted for review on 10-18-13.

- **Rend Lake State Fish & Wildlife Area**

1404371 - This project involves removal of small woody trees. Trees will be removed by mowing, use of bull hog, or removed by dozer. Project was submitted for review on 6-17-13.

- **Edward R. Madigan State Park**

1405733 - This project involves allowing installation of an electrical transmission line in the IDNR right-of-way. Approximately 6 single steel poles would be needed to run the line in 600 foot spans. Project was submitted for review on 10-31-13.

- **Goose Lake Prairie State Natural Area**

1405494 - This project involves rehabilitation of 1.2 miles of Tall Grass Nature Trail, and replacement of numerous culverts. Project was submitted for review on 10-17-13.

- **Pere Marquette State Park**

1313934 - This project involves removal of dredge sediment currently stored in dewatering bags at the harbor. The break wall and surrounding areas will also be repaired. Project was submitted for review on 10-31-13.
