## ENVIRONMENTAL REVIEWS COMPLETED

Project reviews completed from May 15 to June 15 are listed below. These projects have been screened through the internal environmental review process for potential impacts on wetlands, threatened and endangered species, and cultural and archaeological resources, etc. Through the review process it was determined that environmental impacts have been kept to a minimum and mitigated as necessary, that they do not meet the criteria for significant actions as defined in the environmental review process, and may proceed. All of these projects are in compliance with the Endangered Species Protection Act, Natural Areas Preservation Act, Interagency Wetlands Policy Act and cultural resource statutes.

- **William Powers State Recreation Area**

1610615 - This project involves hazardous tree removal from William Powers SRA. Project was submitted for review on 5-10-16.

- **Butterfield Trail State Recreation Area**

1611764 - This project involves moving a flagpole and memorial to the town of Gilman. Project was submitted for review on 6-14-16.

- **Pere Marquette State Park**

1611766 - This project involves repairs to the Lodge roof to correct water leakage. Project was submitted for review on 6-14-16.

- **Ferne Clyffe State Park**

1611338 - This project involves the installation of five new yard hydrants at various picnic areas with Ferne Clyffe SP. Project was submitted for review on 6-1-16.

- **Carlyle Lake State Fish & Wildlife Area**

1610758 - This project involves flood debris removal maintenance at Wildcat Bridge. Project was submitted for review on 5-13-16.

- **Carlyle Lake State Fish & Wildlife Area**

1610752 - This project involves maintenance/rehabilitation of rip-rap at two existing spillways in Levee A & C, Sub-impoundments 1 & 2. Project was submitted for review on 5-13-16.

- **Starved Rock State Park**

1611454 - This project involves using laser technology to remove graffiti located in Ottawa Canyon. Project was submitted for review on 6-16-16.

- **White Pines State Park**

1611332 - This project involves installation of memorial bench. Project was submitted for review on 6-1-16.

- **Clinton Lake State Recreation Area**

1611319 - This project involves construction of a new gravel lot for equestrian parking east of the Parnell Boat Ramp. Invasive vegetation will be cleared for a 0.4 mile trail connection to the existing equestrian trail. Project was submitted for review on 5-25-16.

- **Chain O' Lakes State Park**

1611057 - This project involves transferring approximately 3.917 acres from IDNR to the Fox River Agency. Project was submitted for review on 5-23-16.

- **Chain O' Lakes State Park**

1611060 - This project involves transferring approximately 45 acres from IDNR to the Fox River Agency. Project was submitted for review on 5-23-16.

- **Pere Marquette State Park**

1610976 - This project involves erecting a Commemorative Plaque to acknowledge the significance of the Pere Marquette statue and the French explorers in colonial history. Project was submitted for review on 5-19-16.

- **Shelbyville State Fish & Wildlife Area**

1609736 - This project involves repairs to the flood damaged levees at the Fishhook waterfowl area within Shelbyville SFWA. Project was submitted for review on 4-20-16.

- **Carlyle Lake State Fish & Wildlife Area**

1610756 - This project involves replacing the water control structure. Project was submitted for review on 5-13-16.

- **Oriole Grove**

1610948 - This project involves transferring approximately 84.5 acres from IDNR to the Lake County Forest Preserve District. Project was submitted for review on 5-18-16.

- **Des Plaines State Fish & Wildlife Area**

1610912 - This project involves repairs to pipeline that passes through Des Plaines SFWA. Project was submitted for review on 5-18-16.
