## ENVIRONMENTAL REVIEWS COMPLETED

Project reviews completed from April 15 to May 15 are listed below. These projects have been screened through the internal environmental review process for potential impacts on wetlands, threatened and endangered species, and cultural and archaeological resources, etc. Through the review process it was determined that environmental impacts have been kept to a minimum and mitigated as necessary, that they do not meet the criteria for significant actions as defined in the environmental review process, and may proceed. All of these projects are in compliance with the Endangered Species Protection Act, Natural Areas Preservation Act, Interagency Wetlands Policy Act and cultural resource statutes.

- **Mt. Vernon Game Farm**

1510732 - This project involves the demolition of four dilapidated and unsafe structures at the Mt. Vernon Game Farm. Project was submitted for review on 3-24-15.

- **Tunnel Hill State Trail**

1510588 - This project involves construction of a new trailhead facility adjacent to Wise Ridge/Bedrock Hill State Natural Area. Project was submitted for review on 3-19-15.

- **Tunnel Hill State Trail**

1212877 - This project involves lease or transfer of IDNR property to the Village of Karkak. This part of Tunnel Hill State Trail, lying south of IL Rt. 169, was never developed into a trail and has been allowed to be overgrown. Project was submitted for review on 4-16-12.

- **Weldon Springs State Park**

1511708 - This project involves the demolition and removal of the former assistant site superintendent house at Weldon Springs. Project was submitted for review on 4-24-15.

- **Clinton Lake State Park**

1511711 - This project involves replacement of existing vault toilets in 10 different locations at Clinton Lake. Project was submitted for review on 4-25-15.

- **Horseshoe Lake State Park**

1512180 - This project involves replacement of roof on six site shelters. Project was submitted for review on 5-6-15.

- **Sangchris Lake State Park**

1512324 - This project involves rehabilitation to the sanitary septic leach field at the Deer Run Campground dump station. Project was submitted for review on 5-11-15.

- **Pere Marquette State Park**

1512158 - This project involves construction of a horseshoe pit at the Pere Marquette State Park Lodge. Project was submitted for review on 5-6-15.

- **Rock Cut State Park**

1512159 - This project involves construction of a 24' x 24' shelter in the equestrian campground. Project was submitted for review on 5-6-15.

- **Chain O' Lakes State Park**

1512068 - This project involves construction of a storage shed within an existing aggregate-surfaced and fenced area at Chain O' Lakes service center. Project was submitted for review on 5-4-15.
