ENVIRONMENTAL REVIEWS COMPLETED

Project reviews completed from January 16 to February 15 are listed below. These projects have been screened through the internal environmental review process for potential impacts on wetlands, threatened and endangered species, and cultural and archaeological resources, etc. Through the review process it was determined that environmental impacts have been kept to a minimum and mitigated as necessary, that they do not meet the criteria for significant actions as defined in the environmental review process, and may proceed. All these projects are in compliance with the Endangered Species Protection Act, Natural Areas Preservation Act, Interagency Wetlands Policy Act and cultural resource statutes.

- **Hidden Springs State Forest**

2109484—This project will remove a hazardous log structure on a newly acquired parcel at the site. Project originally submitted for review on 1-15-2021.

- **Des Plaines State Fish & Wildlife Area**

2109584—This project permits soil borings to determine foundation design for two building replacements. Project originally submitted for review on 1-20-2021.

- **Havana Fisheries HQ**

2109592—This project will repair and replace elements of the Havana Fisheries HQ flooring and roof. Project originally submitted for review on 10-20-2020.

- **Giant City State Park**

2109657—This project proposes to construct a new pole barn addition to the Giant City Stables complex. Project originally submitted for review on 1-22-2021.

- **James Pate Philip State Park**

2002247—This project will dismantle various abandoned beaver lodges and dams that are impacting site water levels. Project most recently submitted for review on 1-13-2021.

- **Starved Rock State Park**

2109700—This emergency project request will replace elements of the subfloor in a hotel addition room that experienced water damage. Project originally submitted for review on 1-25-2021.

- **Eldon Hazlet State Park**

2109666—This project will rehabilitate the existing sewage treatment and distribution systems at the park. Project originally submitted for review on 1-22-2021.

- **Starved Rock State Park**

2109891—This project will remove two hazard trees behind the lodge. Project originally submitted for review on 1-27-2021.

- **Black Hawk State Historic Site**

2101103—This project will reconstruct or repair various elements of the Hallburg Museum. Project originally submitted for review on 7-21-2020.

- **Pittsfield Field Office**

2109966—This project proposes to build an herbicide storage shed on site. Project originally submitted for review on 1-31-2021.

- **Pere Marquette State Park**

2109892—This project proposes to plant and maintain a prairie patch intended for pollinator species near the marina. Project originally submitted for review on 1-27-2021.

- **Deer Pond State Natural Area**

2109414—This project will replace two failed culverts at the site in order to maintain hydrology of natural areas. Project originally submitted for review on 1-14-2021.

- **Pullman State Historic Site**

2107496—This project proposes to upgrade elements of the fire suppression, fire alarm, and radiator systems at the site. Project originally submitted for review on 11-20-2020.

- **Illinois Beach State Park**

2106379—This project is in the planning stages to provide a safer and clearer trail route at the north end of the north unit of the park. Project originally submitted for review on 10-07-2020.

- **Pere Marquette State Park**

2110253—This project will excavate a portion of the entrance road to Camp Potawatomi to investigate a

water leak issue. Project originally submitted for review on 2-09-2021.

- **Golconda Marina**

2109991—This project proposes to re-open the former camping areas at Rauchfuss Hill. Project originally submitted for review on 2-01-2021.
