**ESTABLISHMENT OF INTERPRETIVE TRAIL  
AT BREMER SANCTUARY, HILLSBORO**

**Project Description:** As one component in the development of an environmental education program at the H & B Bremer Sanctuary, owned by the Illinois Audubon Society, an interpretive trail will be established along forest and field trails. Besides describing specific vegetation, the signs will also include information on native tallgrass prairie, edge habitat, succession, erosion, non-native and invasive species, habitat restoration and management techniques, and wildlife conservation measures. A number of members of the Hickory Hills Chapter of the I.A.S. serve as volunteer guides for school classes which visit the sanctuary, and summer educational activities are also offered for the public.

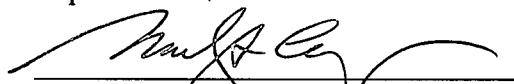
**Methods and Materials:** Signs were designed by teachers who are volunteers at the sanctuary, and reviewed for content and accuracy before being made by a local sign-maker. The signs were placed on backboards and then erected on 4x4 posts. Labor was provided by volunteers from the Hickory Hills Chapter, IAS.

The trail has been completed, and signs are in place. (See enclosed <sup>photos</sup> ~~CD~~)
