APPLICATION INSTRUCTIONS


A snowmobile shall not be required to be registered if it is:

- (1) Owned and operated on lands owned by the owner or operator or on lands to which he has a contractual right other than as a member of a club or association, provided the snowmobile is not operated elsewhere within the state, or
- (2) Used only on international or national competition circuits in events for which written permission has been obtained by the sponsoring or sanctioning body from the governmental unit having jurisdiction over the location of any event held in this State, or
- (3) Designed for use by small children primarily as a toy and used only on private property and not on any public trail.
- (4) Operated by a non-resident that is displaying a valid Illinois trail use sticker.

NON-RESIDENT TRAIL USE STICKER

A person who is not a resident of this State and who operates a snowmobile within this State may register that snowmobile in this State but in the event that he or she does not and he or she is not otherwise exempt he or she must obtain and display a trail use sticker. Trail use stickers are available over-the-counter at all DNR Direct sale locations.

STATE LAW REQUIRES THAT THE PURCHASER OF A SNOWMOBILE SHALL, WITHIN 15 DAYS AFTER PURCHASE, MAKE APPLICATION TO THE DEPARTMENT FOR REGISTRATION. When a snowmobile dealer sells a snowmobile the dealer shall, at the time of sale, require the buyer to complete an application for registration, collect the required fee and mail the application and fee to the Department no later than 14 days after the date of sale.

New Registration

- New Snowmobiles: you must surrender a copy of the Bill of Sale.
- Snowmobiles previously registered or titled in another State: you must surrender the original registration card and/or title.

Note: If Snowmobile has an Illinois Registration Number, complete application as a Transfer Renewal.

- Check the 'New Registration' box.
- Complete section A thru D.
- Fee is \$45; [includes registration card and decals (2)]. Registration is for approximately 3 years.

Warning-snowmobiles purchased new or used from manufacturers, lending institutions, or out of state dealers, are subject to tax. You must contact the Illinois Department of Revenue at 1-800-732-8866 for instructions before submitting an application.

Transfer Renewal

A change of ownership occurs and the snowmobile has an Illinois registration.

- Check the "Transfer Renewal" box.
- Complete section A thru D.
- Surrender the current original Registration Card properly endorsed.
- Fee is \$45; [includes registration card and decals (2)].

Duplicate Registration Card

To replace one which is lost, stolen, destroyed or illegible.

- Check 'Duplicate Registration Card' box.
- Complete section A, B and D.
- Fee is \$5.

Corrected Registration Card

- Check 'Corrected Registration Card' box.
- Complete section A, B and D.
- Surrender current original Registration Card.
- Fee is \$5.

Duplicate Decals (2)

To replace those which are lost or destroyed.

- Check 'Duplicate Decals' box.
- Complete section A, B and D.
- Fee is \$5.

Snowmobile Scraped, Junked or Destroyed

The Department of Natural Resources must be notified, within 15 days, if a registered Snowmobile is scraped, junked or destroyed.

- Complete sections A, B and D.
- Surrender current original Registration Card.
- No fee required.

MANDATORY LIABILITY INSURANCE

625ILCS 40/3-13. Effective April 1, 2011

(a) Other than a person operating a snowmobile on their own property that is not a posted snowmobile trail, and other than a person operating a snowmobile on property other than a posted snowmobile trail in which the owner of the property has given his or her written or oral consent to the person to operate a snowmobile on the property, no person shall operate, register or maintain registration of, and no owner shall permit another person to operate, register or maintain registration of a snowmobile in this State unless the snowmobile is covered by a liability insurance policy.

The insurance policy shall be issued in amounts no less than the minimum amounts set for bodily injury or death and for destruction of property under Section 7-203 of the Illinois Vehicle Code and shall be issued in accordance with the requirements of Sections 143a and 143a-2 of the Illinois Insurance Code as amended. No insurer other than an insurer authorized to do business in this State shall issue a policy pursuant to this Section 3-13. Nothing herein shall deprive an insurer of any policy defense available at common law.

(b) Proof of insurance as required by this Section shall be produced and displayed by the owner or operator of the snowmobile upon request to any law enforcement officer or to any person who has suffered or claims to have suffered either personal injury or property damage as a result of the operation of the snowmobile by the owner or operator.

SNOWMOBILE TRAIL ESTABLISHMENT FUND

Effective April 1, 2011, the Snowmobile Registration Act was amended so that 50% of each registration fee shall be deposited in this fund and shall be used for disbursement upon written application to and subsequent approval by the Department to nonprofit snowmobile clubs and organizations for construction, management, maintenance and rehabilitation of snowmobile trails and areas for the use of snowmobiles.

Temporary Permit

Owner(s) signature on reverse side affirms that a proper Snowmobile application has been submitted to the Illinois Department of Natural Resources and accordingly is permitted to operate the Snowmobile under the Temporary Permit for a period of 60 days from the date of application subject to all provisions of the Illinois Snowmobile Registration and Safety Act. You must carry this document on your person while operating the Snowmobile until the Registration Card is received.
