

MEMORANDUM OF AGREEMENT  
MAIN STREET BRIDGE, SN 022-6752  
NAPERVILLE  
DUPAGE COUNTY

WHEREAS, the Federal Highway Administration (FHWA), U.S. Department of Transportation, has determined that assisting the Illinois Department of Transportation (IDOT) in approving plans by the City of Naperville (CITY), DuPage County, Illinois, for the replacement of the Main Street Bridge (BRIDGE)) carrying Main Street over the West Branch of the DuPage River in said Naperville, will have an adverse effect upon the BRIDGE, a property eligible for inclusion in the National Register of Historic Places (NRHP), and had consulted with the Illinois State Historic Preservation Officer (SHPO) pursuant to the regulations (36 CFR Part 800) implementing Section 106 of the National Historic Preservation Act (17 U.S.C. 470f); and

WHEREAS, IDOT and the CITY participated in consultation and have been invited to concur in this Memorandum of Agreement;

NOW, THEREFORE, the CITY, IDOT, the FHWA, and the Illinois SHPO agree that in accordance with 36 CFR Section 800.6(b)(1)(iv), the undertaking shall be implemented in accordance with the following stipulations to take into account the effect of the undertaking on historic properties.

Stipulations

FHWA, in coordination with IDOT and the CITY, shall ensure that the following measures are carried out.

1. The BRIDGE will be replaced with a new structure as developed in the plans prepared by the CITY and approved by IDOT.
2. Prior to the beginning of construction activities, the CITY shall submit documentation concerning the bridge to the SHPO, to the Level I standards of the Illinois Historic American Engineering Record.
3. The SHPO shall provide the FHWA with a list of the names and addresses of the appropriate local and state archives to receive copies of the final documentation reports to be prepared for compliance with Stipulation 2.
4. IDOT shall list Structure Number 038-3732, the Old Texas Bridge, carrying Township Road 340 over the Iroquois River, Iroquois County, as the substitute for the BRIDGE on the Illinois Historic Bridge Survey
