The Streambank Cleanup And Lakeshore Enhancement (SCALE) program was started by the Illinois Environmental Protection Agency (Illinois EPA) in 2003. The Illinois EPA continued support of the SCALE program by providing financial assistance to selected applicants to conduct lakeshore and streambank cleanup events in 2005 and 2006. The program, funded through Section 319 of the Clean Water Act, provides up to \$3,500 to each group to help with their cleanup efforts. The funds are typically used for safety attire, dumpster rentals, landfill tipping fees and promotional materials. SCALE funds are available only to organizations that have already established a recurring streambank or lakeshore cleanup.

Program Goal

This program was designed to sustain and improve citizen organized lake and river litter collection events to maintain or improve water quality and wildlife habitat. Citizen cleanup events provide hands on activity for adults and students to connect with our local rivers, streams and lakes. Many of those that participate in a clean up event reevaluate their day-to-day activities as they help to clean up their local water resources. Example, recycling and proper household waste disposal make more sense to this audience when they have chosen to spend time cleaning up after others. Many of the SCALE funded events have diversified and now local participants are implementing invasive species removal workdays and storm drain stenciling programs.

Program Implementation

This project ran from September 1, 2004 through January 31, 2007. Program implementation began in October 2004, when Illinois EPA announced the 2005 SCALE program and application deadline. An identical implementation process was carried out for the 2006 SCALE program starting in October 2005.

An application package was sent to approximately 100 civic and environmental groups. The mailing list included past SCALE recipients, Section 319 applicants, regional planning commissions and local government offices throughout the state.

The application package included a brochure and an application to be returned to Illinois EPA by November 30th. The application asked for a history of the organization's past three clean-up events, including:

- the year it was held,
- the waterbody involved,
- the number of participants, and
- the size of area that had been cleaned in acres or miles.

The information submitted by the applicants to Illinois EPA was entered into an Excel spreadsheet. Illinois EPA staff reviewed the data range for the number of participants, area covered and whether the waterbody was listed as an impaired water body (303d list). Using the Excel spreadsheet, a ranking criterion was developed that gave points according to the numbers reported. There was a maximum of 105 points. Point scores were totaled and a grant dollar amount of \$3,500, \$1,750, \$1,000, or \$500 was applied to the ranked projects. In 2005, the maximum grant amount was increased from \$2,000 to \$3,500 to help provide additional funds for the largest cleanup events.

Point summary for the ranking criteria used in 2005 and 2006.

- Applications with a point score of 80 points or more qualified for \$3,500.
- Applications with a point score of 50 – 79 points qualified for \$2,000.
- Applicants with a point score between 40 and 49 qualified for \$1,000.
- Applicants that scored between 20 and 39 points qualified for \$500.
- Applications that did not score at least 20 points did not qualify to receive SCALE funds.

See the Table 1 for the Recipients and Grant Amounts and data reported.

Illinois EPA sent out approval letters and Grant Acceptance Forms to the approved applicants. The Recipients were given 30 days to complete and return the Grant Acceptance Form. Once Illinois EPA received the form, the Illinois EPA staff processed an invoice for the Recipient. In most cases, the Recipients received their SCALE grant prior to conducting their cleanup event.

Illinois EPA staff forwarded a copy of an Event Reporting Form to each of the grant recipients. Recipients were required to submit the following information within 60 days of the event date:

* In most cases, the actual tons of litter collected were not weighed. Getting the citizen organizations to estimate the number of tons collected was difficult at best. Questions such as “wet weight” and “dry weight” came up. Large items like refrigerators and tires also threw off the system.

The data submitted was entered into the Excel spreadsheet and the photos were scanned and saved on CD.

A total of 65 applications were received for the 2005 SCALE program. Forty-four applications were approved for funding for a total cost of \$43,250. Nineteen applications were not recommended for funding for the following reasons:

- The nineteen applicants had project areas that overlapped with at least one other SCALE application area and the same event date. The applicant with the higher point total (according to the modified criteria) was approved for the SCALE funds. Most of these projects were located within the Illinois River Sweep Project.

A total of 33 applications were received for the 2006 SCALE program. Thirty applications were approved for funding for a total cost of \$35,250. Three applications were not recommended for funding for the following reasons:

- Out of a possible 105 points, each of the three denied applications scored less than 20 points.

A number of past SCALE recipients have identified that the area that they clean up, is not in need of a cleanup every year. Most of these groups have identified that they have plans to conduct their cleanup events on alternating years.

Program Schedule

The program period ran from September 1, 2004 through January 31, 2007.

Program Budget

A total of \$100,000 was originally committed to project 3190404. One hundred percent of the project funds (\$78,500) that were distributed to organizations were used for the implementation of cleanup events. No matching funds were documented for this program.

Results

The Ohio River Valley Water Sanitation Commission (ORSANCO) collected the most litter at 1,000 tons (2005). The Friends of the Chicago River had the greatest number of participants 3,700 (2005) and also covered the largest area – 157 miles (2005). The Lower Kaskaskia Stakeholders Inc. removed an entire kitchen (including the sink) from their river.

Overall in 2005 and 2006, SCALE participants removed over 1,700 tons of trash from more than 1,500 miles of streams, and 2,000 acres of lakes in Illinois. Over 25,000 people participated overall!
