The Streambank Cleanup And Lakeshore Enhancement (SCALE) program was started by the Illinois Environmental Protection Agency (Illinois EPA) in 2003. The Illinois EPA continued support of the SCALE program by providing financial assistance to selected applicants to conduct lakeshore and streambank cleanup events in 2007 and 2008. The program, funded through Section 319 of the Clean Water Act, provides up to \$3,500 to each group to help with their cleanup efforts. The funds are typically used for safety attire, dumpster rentals, landfill tipping fees and promotional materials. SCALE funds are available only to organizations that have already established a recurring streambank or lakeshore cleanup.

Program Goal

This program was designed to sustain and improve citizen organized lake and river litter collection events to maintain or improve water quality and wildlife habitat. Citizen cleanup events provide hands on activity for adults and students to connect with our local rivers, streams and lakes. Many of those that participate in a clean up event reevaluate their day-to-day activities as they help to clean up their local water resources. Example, recycling and proper household waste disposal make more sense to this audience when they have chosen to spend time cleaning up after others. Many of the SCALE funded events have lead to local participants implementing additional events that include invasive species removal workdays, water quality monitoring, and storm drain stenciling programs.

Program Implementation

This project ran from September 1, 2006 through January 31, 2009. Program implementation began in October 2006, when Illinois EPA announced the 2007 SCALE program and application deadline. An identical implementation process was carried out for the 2008 SCALE program starting in October 2007.

An application package was sent to approximately 100 civic and environmental groups. The mailing list included past SCALE recipients, Section 319 applicants, regional planning commissions and local government offices throughout the state and others who had expressed an interest in the SCALE program.

The application package included a brochure and an application to be returned to Illinois EPA by early December. The application asked for a history of the organization's past three clean-up events, including:

- the year it was held,
- the waterbody involved,
- the number of participants, and
- the size of area that had been cleaned in acres or miles.

The information submitted by the applicants to Illinois EPA was entered into an Excel spreadsheet. Illinois EPA staff reviewed the data range for the number of participants, area covered and whether the waterbody was listed as an impaired water body (303d list). Using the Excel spreadsheet, a ranking criterion was developed that gave points according to the numbers reported. There was a maximum of 105 points. Point scores were totaled and a grant dollar amount of \$3,500, \$1,750, \$1,000, or \$500 was applied to the ranked projects.

Point summary for the ranking criteria used in 2007 and 2008.

- Applications with a point score of 80 points or more qualified for \$3,500.
- Applications with a point score of 50 – 79 points qualified for \$2,000.
- Applicants with a point score between 40 and 49 qualified for \$1,000.
- Applicants that scored between 20 and 39 points qualified for \$500.
- Applications that did not score at least 20 points did not qualify to receive SCALE funds.

See the Table 1 for the Recipients and Grant Amounts and data reported.

Illinois EPA sent out approval letters and Grant Acceptance Forms to the approved applicants. The Recipients were given 30 days to complete and return the Grant Acceptance Form. Once Illinois EPA received the form, the Illinois EPA staff processed an invoice for the Recipient. In most cases, the Recipients received their SCALE grant prior to conducting their cleanup event.

The SCALE participants found 2008 to be an extremely wet year. A number of the SCALE events had to be postponed until the water levels receded. Participant safety and inability to reach much of the litter was the motivation behind postponing the events. Two organizations, the Friends of Sangamon Valley and the JoDaviess Conservation Foundation, were unable to hold their clean up events due to high water levels. Both of these organizations notified Illinois EPA prior to their 2008 SCALE event date and made arrangements with Illinois EPA to defer their 2008 SCALE event until 2009.

Illinois EPA staff forwarded a copy of an Event Reporting Form to each of the grant recipients. Recipients were required to submit the following information within 60 days of the event date:

* In most cases, the actual tons of litter collected were not weighed. Getting the citizen organizations to estimate the number of tons collected was difficult at best. Questions such as “wet weight” and “dry weight” came up. Large items like refrigerators and tires also threw off the system.

The data was entered into the Excel spreadsheet and many of the photos were scanned and saved.

A total of 28 applications were received for the 2007 SCALE program. All 28 were approved for funding for a total cost of \$35,000. In May 2007, the Salt Fork River Partners (Partners) contacted Illinois EPA to withdraw their 2007 application. They had remaining 2006 SCALE funds. They agreed that they would use the remaining 2006 funds to hold their 2007 SCALE event. The 2007 SCALE program total cost was reduced to \$34,000.

A total of 32 applications were received for the 2008 SCALE program. All 32 applications were approved for funding for a total cost of \$34,500.

As in 2005 and 2006, a number of past SCALE recipients have identified that the area that they clean up, is not in need of a cleanup every year. Most of these groups have identified that they have plans to conduct their cleanup events on alternating years.

Photo Contest

In 2008, Illinois EPA added a photo contest to encourage our SCALE participants to share great photos of their cleanup events. Submission of event photos was already a requirement of the SCALE program, but many of the photos submitted, did not capture the “heart and soul” of the SCALE program.

Illinois EPA will use the photos from this contest in information and outreach materials to help others better understand the importance of the work that is being done to clean up our lakes and streams.

Winning pictures will show the SCALE program at its best: basically people near a lake or stream safely picking up litter and debris. The photos should reinforce safety and common sense. When appropriate, life jackets and other safety equipment should be shown.

The following prizes were awarded for the 2008 photo contest:

First Place	\$250	United Sportsmen’s Youth Foundation
Second Place	\$175	Northern Illinois Angler’s Association
Third Place	\$100	Fox Waterway Agency

Prize funds will be provided as an increase in the winners’ 2009 SCALE grant award. The prize funds will have the same restrictions as the regular SCALE program funds. So, if an organization wins first prize in the photo contest and is approved for a \$1,000 SCALE grant in 2009, they will receive a payment for \$1,250.00 from Illinois EPA to implement their 2009 SCALE event. In the event that a contest winner is not approved for a 2009 SCALE grant, the prize money will be forfeited and given to the next organization in line from the photo contest as determined by Illinois EPA.

Photo Contest Rules

1. The contest is open to all organizations participating in the 2008 SCALE program.
2. Illinois EPA may use the submitted photos to promote environmental programs and projects.
3. An organization may submit a maximum of three 8 by 10 inch photos depicting their 2008 SCALE event. An electronic copy of each photo must also be submitted to Illinois EPA. This can be done on CD or by email.
4. Photos can be in color or black and white.
5. An organization can win only one prize per year.
6. Photos must be labeled, and include the following information: organization name, location where photo was taken (include lake or stream name), date, photo title, and photographer's name (for credit purposes).
7. Do not frame or mat photos.
8. Contest Deadline—November 1, 2008.
9. The photos submitted for this contest are in addition to the photo documentation requirement of the 2008 SCALE program. Although the photos submitted for the contest may be included as part of the SCALE photo submittal.
10. All prize funds awarded by Illinois EPA will be used to continue implementation or expansion of SCALE stream and lakeshore cleanup efforts.

Program Budget

A total of \$100,000 was originally committed to project 3190603. One hundred percent of the project funds (\$68,500) that were distributed to organizations were used for the implementation of cleanup events. No matching funds were documented for this program.

Results

- The Northern Illinois Angler's Association collected the most litter at 55 tons (2007).
- The Ohio River Valley Water Sanitation Commission (ORSANCO) covered the largest area – 150 miles (2008).
- The Friends of the Chicago River had the greatest number of participants 3,800 (2008)

In 2007 and 2008, SCALE participants removed over 350 tons of trash from almost 1,500 miles of streams, and 350 acres of lakes in Illinois. Almost 27,000 people participated overall!
