Pam Lowry welcomed meeting participants
- **Remarks – Maggie Bennett**

- **CSAC Quarterly Numbers – Pam Lowry**  
Debt Percent is slightly up. We are continuing to follow the caseload. Currently quarterly results are slightly up from the same quarter last year. We continue to monitor the caseload. Due to age of the system, our capacity for data analytics is limited.
- **Income Shares Implementation Status – All members who wish to speak**  
Implementation has been smooth. Members congratulated the HFS team and other members. Illinois' next guidelines review will occur in 2021, but updates to the tax tables and schedule of basic obligation will be conducted as needed, or on an annual basis.

Judges and IV-D legal representatives may request additional training from HFS if needed.

- **New Business – Committee Members**

Uniform Support Order. The Chair indicated that she would like the committee to work on the Uniform Support Order. Irene Curran indicated that Yvette Perez Trevino and Irene were working with the SAO to create a temporary order until the Supreme Court creates a new form based on income shares.

- **Public Comment – Members of the Public**

A member of the public asked when the tables will be updates. HFS staff responded that the timeline is not yet known.

A member of the public asked why there are two calculations. HFS staff responded there is only one calculation, but it is displayed in three formats – one for parents, one for title IV-D legal representatives, and one for private attorneys and judges.

A member of the public asked about Administrative rules. HFS staff responded the Rule changes are in progress but the statute is in place.

A member of the public asked about withholding for child care. HFS staff responded that child care withholding is not covered by Title IV-D.
