Background on the DCFS managed care transition was provided – DCFS and HFS have worked collaboratively to develop the contract and select Illinicare as the provider. Transition designed to improve clinical outcomes, particularly for youth with the most complex needs.

There will be regular review of outcomes of youth in care, in order to identify barriers and issues and work through them.

Illinicare shared information about their work, including network expansion efforts and specialized programs, including one for adoptive families and another for older youth transitioning to adulthood.
