Whereas the above bound principal is desirous of being licensed by the Illinois Department of Labor to operate and maintain a private employment agency from the approval and issuance of the license dated contemporaneously with this instrument, it is a condition of this obligation that said principal shall act in accordance with the PRIVATE EMPLOYMENT AGENCIES ACT 225 ILCS 515/0.1 et seq. and the applicable Rules of the Illinois Department of Labor 68 ILL. ADMIN. CODE 680.200 et seq.

Now, the said principal shall faithfully observe all the duties, terms, conditions, provisions or requirements of the laws in relation to said private employment agencies.

If the surety herein shall so elect, this bond may be conditionally canceled at any time by the surety herein filing with the Division of Private Employment Agencies of the State of Illinois and by certified mail to the above principal a sixty (60) day written notice of such conditional cancellation, but said surety so filing said notice shall not be discharged from any liability already accrued under this bond or which shall accrue there under before the expiration of said sixty (60) day period.
