**THIS MATTER COMING** on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and Notice of Hearing issued thereunder; and, the Associated General Contractors of Illinois and the Southern Illinois Builders Association's ("AGCI") October 24, 2017 Petition to Intervene and AGCI's October 30, 2017 Notice of Voluntary Withdrawal and Petitioner's and Intervenor's signed Joint Withdrawal in this consolidated matter, pursuant to 56 Illinois Administrative Code 120.400 (a) (1-6) all parties having been duly advised in the premises, the undersigned issues this order;

**IT IS HEREBY ORDERED:**

1. The October 30, 2017 Notice of Voluntary Withdrawal of AGCI's October 24, 2017 Petition to Intervene filed in 2018-H-AS09-1971 is granted. The Petition is Withdrawn.

2. Petitioner and Intervenor's signed Joint Withdrawal of its Objections that are the subject of 2018-H-AS09-1971 and 2018-H-PK07-1916 is granted.
3. The pre-hearing conference scheduled on November 2, 2017 at 12:30 p.m. is stricken and canceled.
4. The hearing scheduled for November 7, 8 and 9, 2017 at 160 N. LaSalle St., Ste. C-1300 Chicago, IL 60601 is stricken and canceled.
5. This consolidated matter is dismissed.
6. Pursuant to 56 Illinois Administrative Code 120.640, the administrative law judge shall issue a Decision and Order. In the event, no timely or proper exceptions are filed, the findings, conclusions, recommendations and order of the administrative law judge shall automatically become the decision and order of the Director of Labor.
