1. Stark County, Illinois is added to the above captioned action.
2. The caption of this matter is amended as reflected above.
3. Electrician in Bureau, Ford, Grundy, Henry, Kankakee, Stark, LaSalle and Will Counties, Illinois are dismissed with prejudice.
4. Communication Technician in Grundy, Iroquois, Kankakee, Stark, LaSalle, and Will Counties, Illinois are dismissed with prejudice.
5. Putnam County is dismissed with prejudice as to the region of coverage.
