ORDER

THESE MATTERS COMING on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and Notice of Hearing issued thereunder, and, pursuant to 56 Ill. Admin. Code 120.400(a)(1-6), all parties being duly advised in the premises, issues this order sua sponte:

IT IS HEREBY ORDERED:

1. A pre-hearing conference shall be convened via telephone on October 19, 2018 at 2:00 p.m. The parties shall provide the telephonic contact number to DOL.hearings@illinois.gov to the attention of the undersigned by close of business October 18, 2018. In the event the parties do not provide telephone numbers by that date, this Tribunal will attempt to reach the parties at, in the case of Petitioner, the phone number or phone numbers listed on the Petition, and, in the case of Respondents, at (312) 793-1966.

2. The pre-hearing conference shall be held to discuss potential consolidation of the above-listed proceedings, simplify the issues, determine necessity or desirability of amendment to documents for purposes of clarification, simplification or limitation, determine stipulations, admission of fact and of contents and authenticity of the documents, limit the number of witnesses, determine propriety of the prior mutual exchange among the parties who have prepared testimony or exhibits, discuss intervention and decide other matters as may tend to expedite the disposition of the proceedings and to assure a just conclusion thereof.
