ORDER

THIS MATTER having come to be heard before the Liquor Control Commission of the State of Illinois (hereinafter “the Commission”) upon the appeal of Kinzie Liquor Inc., Appellant, this Commission being otherwise fully informed does hereby state the following:

An order was entered by the Local Liquor Commission for the Village of Bradley, Illinois on June 6, 2018, denying Appellant’s application for a liquor license. Appellant filed its appeal on June 20, 2018. On April 9, 2019, Appellant filed a motion to dismiss it’s appeal pursuant to a settlement agreement reached between Appellant and the Village of Bradley, Illinois. The matter was heard and deliberated on by the Commission on April 17, 2019.

IT IS HEREBY ORDERED:

This matter is dismissed with prejudice, pursuant to the aforementioned settlement agreement. Each party to bear its own costs and fees.

THIS IS A FINAL ORDER

Pursuant to 235 ILCS Sec. 5/7-10 of the Illinois Liquor Control Act, a Petition for Rehearing may be filed with this Commission within twenty (20) days from the service of this Order. The date of mailing is deemed to be the date of service. If the parties wish to pursue an Administrative Review action in the Circuit Court, the Petition for Rehearing must be filed within twenty (20) days after service of this Order as such Petition is a jurisdictional prerequisite to the Administrative Review.


