**FINAL ORDER**

THIS MATTER having come to be heard before the Liquor Control Commission of the State of Illinois (hereinafter “the Commission”) upon the appeal THE PUBLIC LEAGUE, INC, Appellant, the Commission being otherwise fully informed does hereby state the following:

An order was entered by the Local Liquor Commissioner for Harvey, Illinois on January 10, 2020. On January 30, 2020, Appellant filed its appeal to the Commission. On January 8, 2021, Appellee vacated the order entered on January 10, 2020. On January 12, 2021, Appellant and Appellee filed a joint motion to dismiss the appeal. On January 20, 2021, the Commission deliberated the matter.

IT IS HEREBY ORDERED:

1. The Joint Motion to Dismiss is GRANTED.
2. This matter is DISMISSED with prejudice.

THIS IS A FINAL ORDER

Pursuant to 235 ILCS 5/7-10 of the Illinois Liquor Control Act, a Petition for Rehearing may be filed with this Commission within twenty (20) days from the service of this Order. The date of mailing is deemed to be the date of service. If the parties wish to pursue an Administrative Review action in the Circuit Court, the Petition for Rehearing must be filed within twenty (20) days after service of this Order as such Petition is a jurisdictional prerequisite to the Administrative Review.


