Brand Registration; Combination Packaging; Formula Change; Gift Packaging; Label Revision; Packaging Change; Promotion; Proof Change; Size Change; This Certificate of Label Approval that is issued by the Federal Tax and Trade Bureau must containan identical brand name, fanciful name and product type as entered below. If you are not the actual manufacturer of the product you must provide an appointment letter from the manufacturer. If you are a distributor, you MUST provide a document from the manufacturer that must contain permission by the manufacturer authorizing the distributor to register the specific brand with the ILCC.
