Fees: \$1,500 per diem for each day of hearing (8 hr. maximum). Time spent in hearings beyond 8 hours, excluding lunch, travel time for hearings outside the Chicago, and preparation of the award will be billed at a rate of \$275 per hour. Travel expenses including air fare, hotel and mileage (IRS rate) will be charged, as incurred.

Cancellation: One-half per diem, plus non-refunded expenses and change fees, will be charged for hearings cancelled less than 30 days in advance of schedule, except that one full day per diem will be charged for hearings cancelled less than 14 days in advance. Travel, including air fare and hotel, will not be arranged until 14 days prior to hearing unless otherwise directed by the parties.
