I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL

II. PRESENT

III. APPROVAL OF MINUTES OF JOINT PANEL MEETING HELD DECEMBER 9, 2008

Chairman Zimmerman called for approval of the minutes of the December 9, 2008 meeting. Member Washington made a motion for approval of the minutes. Member Anderson seconded. The Board passed the motion—four in favor, none against—Member Coli and Chairman Zimmerman abstained.

Member Coli then made a motion to return to open session. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.
