Minutes of the Local Panel Meeting

I. OPENING OF MEETING 11:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL

II. PRESENT

Robert M. Gierut, Chairman; Charles E. Anderson, Member of the Board; Richard Lewis, Member of the Board; Melissa Mlynski, Executive Director; Jerald S. Post, General Counsel; and staff members.

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD April 16, 2013

Chairman Gierut called for approval of the minutes of the April 16, 2013 meeting. Member Anderson moved to approve the minutes. Member Lewis seconded. The Board passed the motion unanimously, by a voice vote.

IV. ADMINISTRATIVE MATTERS

Chairman Gierut asked Executive Director Mlynski to present the Local Panel administrative actions report for the period of time from April 1 through April 30, 2013. She presented the report and summarized its highlights. The Board examined the report and discussed it.

V. LEGISLATIVE AND FISCAL REPORTS

Executive Director Mlynski reported various legislative issues. She then presented the fiscal report, reviewing in detail the general ledger sheet and the disbursement record. The Board then discussed and questioned various aspects of the fiscal report.

VI. BOARD ACTIONS

1. Case No. L-CA-12-044

International Brotherhood of Teamsters, Local 700/ County of Cook and Sheriff of Cook County

Chairman Gierut asked General Counsel Post to call and present the case. General Counsel Post stated that on January 24, 2013 Administrative Law Judge (ALJ) Anna Hamburg-Gal issued a recommended decision and order (RDO) finding that the Respondent did not violate Section 10(a)(4) and (1) of the Illinois Public Labor Relations Act. General Counsel Post then reviewed the issues raised by the Charging Party's exceptions and recommended that the Board affirm the ALJ's RDO. After discussion, Member Lewis moved to accept the RDO. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

2. Case No. L-CA-12-052

George Fielder/ City of Chicago

Chairman Gierut called the case, noting that no party filed exceptions to ALJ Kehoe's RDO, and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

3. Case No. L-CB-13-026

Marketa Kristofek/ Service Employees International Union, Local 73

Chairman Gierut asked General Counsel Post to call and present the case. General Counsel Post stated that the Executive Director issued a dismissal on February 13, 2013 and that the Charging Party filed an appeal alleging that Respondent failed its duty to provide fair representation and thus violated Section 10(b)(1) of the Illinois Public Labor Relations Act. Respondent had filed a response to the appeal as well as a motion to strike documents. After

General Counsel Post presented and discussed the issues of the case he recommended that the Board deny the motion to strike documents and to affirm the Executive Director's dismissal. After discussion, Member Lewis made a motion to affirm the recommendation to deny the motion to strike documents. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote. Member Lewis moved to affirm the Executive Director's dismissal, Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

VII. EXECUTIVE SESSION

After a short discussion regarding whether there was a need for executive session, the Board concluded that it was not necessary at this time.

VIII. ADJOURNMENT

Chairman Gierut called for a motion to adjourn. Member Anderson made a motion to adjourn the meeting, and the Board passed it unanimously, by a voice vote.
