**Minutes of the Local Panel Meeting**

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL**

**II. PRESENT**

Charles E. Anderson, Member of the Board; Edward E. Sadlowski, Member of the Board; John F. Brosnan, Executive Director; Jerald S. Post, General Counsel; and staff members. Member Sadlowski chaired the meeting.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD APRIL 13, 2010**

Member Sadlowski called for approval of the minutes of the April 13, 2010 meeting. Member Anderson moved to approve the minutes. Member Sadlowski seconded. The Board passed the motion unanimously, by a voice vote.

**1. Case No. L-CB-08-012**

**Michael Lyman/Chicago Fire Fighters Union, Local 2**

General Counsel Post reviewed the issues presented by the appeal and recommended that the Board accept the executive director's dismissal. **2. Case No. L-CB-09-020**

**Kelvin Brown/Amalgamated Transit Union, Local 241**

Member Sadlowski called the case, noting that Executive Director Brosnan issued a dismissal on March 1, 2010, with an appeal filed. General Counsel Post reviewed the issues presented by the appeal and recommended that the Board accept the executive director's dismissal. After discussion, Member Anderson moved to accept the executive director's dismissal. Member Sadlowski seconded the motion, and the Board passed it unanimously, by a voice vote.
