**Minutes of the Local Panel Meeting**  
**Held on June 5, 2007**

**I. OPENING OF MEETING 11:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL**

**II. PRESENT**

Jackie Gallagher, Chairman; Charles Anderson, Member of the Board; Edward E. Sadlowski, Member of the Board; John F. Brosnan, Executive Director; and staff members.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD MAY 8, 2007**

Chairman Gallagher called for approval of the minutes of the May 8, 2007 meeting. Member Sadlowski made a motion for approval of the minutes. Chairman Gallagher seconded the motion. The Board approved the motion unanimously, by a voice vote.

**IV. ADMINISTRATIVE MATTERS**

Chairman Gallagher asked Executive Director Brosnan to present the Local Panel administrative actions for the period of time from June 1 through June 30, 2007. He distributed the report to the Board for review, and the Board examined and discussed it.

**Chicago Transit Authority/Amalgamated Transit Union, Local 241**

**Amalgamated Transit Union, Local 241/Chicago Transit Authority**

Chairman Gallagher began by summarizing the case, noting that on April 30, 2004, the Board considered this matter and accepted the ALJ's recommendation in almost its entirety, reversing only his dismissal of the Union's 10(a)(1) allegation. Chairman Gallagher further noted that the CTA thereafter appealed the Board's decision to the Illinois Appellate Court, and the court vacated the Board's order and remanded the matter for reconsideration. The Board then proceeded to discuss the matter at length. At the conclusion thereof, Chairman Gallagher suggested that a draft decision might assist the Board. Member Sadlowski moved that Acting General Counsel Brosnan prepare a draft decision for review at the next meeting. Chairman Gallagher seconded the motion, and the Board passed it unanimously, by a voice vote.

**VI. OTHER BOARD MATTERS**

Member Sadlowski made motion that the Local Panel discuss the fiscal and legislative reports at the Joint Panel meeting scheduled for 11:30 a.m. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

Chairman Gallagher called for a motion to adjourn. Member Sadlowski made a motion to adjourn the meeting, and the Board passed it unanimously, by a voice vote.
