**Minutes of the Local Panel Meeting**  
**Held on January 6, 2009**

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL**

**II. PRESENT**

Jackie Gallagher, Chairman; Charles Anderson, Member of the Board; Edward E. Sadlowski, Member of the Board; John F. Brosnan, Executive Director; and staff members. John F. Brosnan and Sylvia Rios acted as counsel to the Board at this meeting.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD DECEMBER 9, 2008**

Chairman Gallagher called for approval of the minutes of the December 9, 2008 meeting. Member Anderson made a motion for approval of the minutes. Member Sadlowski seconded the motion. The Board approved the motion unanimously, by a voice vote.

**IV. ADMINISTRATIVE MATTERS**

Chairman Gallagher asked Executive Director Brosnan to present the Local Panel administrative actions for the period of time from December 1 through December 31, 2008. He distributed the report to the Board for review, and the Board examined and discussed it.

**V. BOARD ACTIONS**

1. **Case Nos. L-RC-06-024 and L-RC-07-035**  
**American Federation of State, County and Municipal Employees, Council 31/Service Employees International Union, Local 73/County of Cook**

Chairman Gallagher called the case, noting that no party filed exceptions to Administrative Law Judge Strizak's Recommended Decision and Order, and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

2. **Case No. L-CA-08-056**  
**Jorge H. Quinones/Forest Preserve District of Cook County**  
**Case No. L-CB-08-020**  
**Jorge H. Quinones/International Brotherhood of Teamsters, Local No. 726**

Chairman Gallagher called the cases, noting that Executive Director Brosnan issued a dismissal on August 26, 2008, with an appeal filed. Acting General Counsel Rios reviewed the issues presented by the appeal and recommended that the Board uphold the Executive Director's dismissal. After discussion, Member Anderson moved to accept the Executive Director's dismissal. Member Sadlowski seconded the motion, and the Board passed it unanimously, by a voice vote.

**VI. OTHER BOARD MATTERS**

Chairman Gallagher noted that there was little to report regarding either fiscal or legislative matters. Thereafter, the Board discussed whether there was a need for executive session, concluding it was not necessary at this time.
