**Minutes of the Local Panel Meeting**  
**Held on December 14, 2010**

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL**

**II. PRESENT**

Jacalyn J. Zimmerman, Chairman; Charles E. Anderson, Member of the Board; Edward E. Sadlowski, Member of the Board; John F. Brosnan, Executive Director; Jerald S. Post, General Counsel; and staff members.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD NOVEMBER 9, 2010**

Chairman Zimmerman called for approval of the minutes of the November 9, 2010 meeting. Member Sadlowski moved to approve the minutes. Member Anderson seconded. The Board passed the motion unanimously, by a voice vote.

**IV. ADMINISTRATIVE MATTERS**

Chairman Zimmerman asked Executive Director Brosnan to distribute the Local Panel administrative actions report for the period of time from November 1 to November 30, 2010. He distributed the report to the Board and summarized its highlights. The Board examined the report and discussed it.

**V. BOARD ACTIONS**

**Case Nos. L-CA-09-046 and L-CA-09-099**

**Leslie Mitchner/Beverly Joseph/Cook County Juvenile Temporary Detention Center**

Chairman Zimmerman called the case. General Counsel Post reviewed the issues presented by the exceptions to Administrative Law Judge (ALJ) Clifford's Recommended Decision and Order, and recommended that the Board accept in part, and reject in part, the ALJ's recommendation. After discussion, Chairman Zimmerman moved to accept General Counsel Post's recommendation. Member Sadlowski seconded the motion. Chairman Zimmerman and Member Sadlowski passed the motion by a voice vote. Member Anderson opposed, arguing that the ALJ's recommendation should be rejected in its entirety.

**VI. OTHER BOARD MATTERS**

The Board opted to review the fiscal and legislative reports in the joint panel meeting scheduled for 10:30 a.m. on this date. After a short discussion regarding whether there was a need for executive session, the Board concluded that it was unnecessary at this time.

**VII. ADJOURNMENT**

Chairman Zimmerman called for a motion to adjourn. Member Sadlowski made a motion to adjourn the meeting, and the Board passed it unanimously, by a voice vote.
