**Minutes of the Local Panel Meeting  
Held on June 9, 2016**

**I. OPENING OF MEETING 10:00 A.M.—160 N LaSalle Street, 4<sup>th</sup> Floor, Room S401, Chicago, IL**

**II. PRESENT**

Robert M. Gierut, Chairman; Charles E. Anderson, Member of the Board; Richard Lewis, Member of the Board; Kathryn Zeledon Nelson, General Counsel; Anna Hamburg-Gal, Associate General Counsel; and staff members. Melissa Mlynski, Executive Director; Sarah Kerley, Deputy General Counsel; and staff members participated via telephone conference from the Board's Springfield office.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD ON May 10, 2016**

Chairman Gierut called for approval of the minutes of the May 10, 2016 meeting. Member Anderson moved to approve the minutes. Member Lewis seconded. The Board passed the motion unanimously, by a voice vote.

**V. BOARD ACTIONS**

**1. Case No. L-CA-16-007  
Sherise M. Hogan/Chicago Transit Authority**

Chairman Gierut called the case and asked General Counsel Nelson to present the issues to the Board. General Counsel Nelson stated that the Executive Director issued an Order Holding Case in Abeyance and that Charging Party filed an appeal. After her presentation, General Counsel Nelson recommended that the Board accept the Executive Director's Order. After discussion, Member Lewis moved to affirm the Executive Director's Order Holding Case in Abeyance. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-CB-16-015  
James Kondilis/International Brotherhood of Teamsters, Local 700**

Chairman Gierut called the case and asked General Counsel Nelson to present the issues to the Board. General Counsel Nelson stated that the Executive Director issued a dismissal on a charge alleging that the Respondent violated Section 10(b) of the Act and that Charging Party filed an appeal and a supplemental appeal. After her presentation, General Counsel Nelson recommended that the Board deny Charging Party's supplemental appeal and to accept the Executive Director's dismissal. After discussion, Member Anderson moved to deny the supplemental appeal. Member Lewis seconded the motion, and the Board passed it unanimously, by a voice vote. Then Member Lewis moved to affirm the Executive Director's dismissal. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**VI. EXECUTIVE SESSION**

After a short discussion regarding whether there was a need for executive session, the Board concluded it was unnecessary.
