**Minutes of the Local Panel Meeting

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL**

**II. PRESENT**

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD January 9, 2018**

Chairman Gierut called for approval of the minutes of the January 9, 2018 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

**IV. ADMINISTRATIVE MATTERS**

Chairman Gierut asked Executive Director Stevens to present the Executive Director's reports. She presented the reports and summarized the highlights.

**V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS**

**1. Case No. L- CA-14-066  
Amalgamated Transit Union, Local 308/Chicago Transit Authority**

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**VI. BOARD ACTIONS**

**1. Case No. L-RC-14-004  
Teamsters, Local 700/County of Cook and Cook County Sheriff**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to reject the Administrative Law Judge's Recommended Decision and Order. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-RC-17-016  
Metropolitan Alliance of Police, Cook County Sheriff's Police Lieutenants, Chapter 750/County of Cook and Cook County Sheriff**

General Counsel Kim called the case, noted that no party filed exceptions to Administrative Law Judge Anna Hamburg-Gal's Recommended Decision and Order and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CB-18-002  
Edward Donaldson/Amalgamated Transit Authority, Local 241**

General Counsel Kim asked Associate General Counsel Hamburg-Gal to call and present the issues of the case to the Board. After discussion, Member Anderson moved to accept the Executive Director dismissal with a modification. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

**4. Case No. L-CB-16-038**  
**Theopolis Hoffman/Service Employees International Union, Local 73**

General Counsel Kim asked Associate General Counsel Hamburg-Gal to call and present the issues of the case to the Board. After discussion, Member Anderson moved to reject the Executive Director's Order and approve the variance. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.
