I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD February 6, 2018

Chairman Gierut called for approval of the minutes of the February 6, 2018 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

**1. Case No. L-RC-14-004
Teamsters, Local 700/County of Cook and Cook County Sheriff**

**2. Case No. L-CB-18-002
Edward Donaldson/Amalgamated Transit Union, Local 241**

General Counsel Kim called the case. Member Anderson made a motion to approve the proposed written decision. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

**1. Case No. L-CA-16-017
Erek Slater/Chicago Transit Authority**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to accept the Administrative Law Judge's Recommended Decision and Order with modification. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-CA-16-023
Randle E. Martin/City of Chicago (Department of Streets and Sanitation)**
