III. APPROVAL OF MINUTES OF REGULAR MEETING HELD August 7, 2018

Chairman Gierut called for approval of the minutes of the August 7, 2018 meeting. Member Thomas moved to approve the minutes. Member Anderson seconded. The Board passed the motion unanimously, by a voice vote.

**3. Case No. L-CA-14-066
Amalgamated Transit Union, Local 308 and Chicago Transit Authority**

General Counsel Kim called the case. Member Anderson made a motion to approve the proposed written decision. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

**1. Case No. L-CB-16-036
Al Wagner and Automobile Mechanics Union, Local #701**

Chairman Gierut recused himself from the case. General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Anderson moved to deny the motion to strike the charging party's appeal and to accept the Administrative Law Judge's Recommended Decision and Order with modification. **2. Case No. L-CB-17-036
Carroll McGregor and Service Employees International Union, Local 73**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Anderson moved to grant a variance to allow charging party's appeal and to accept the Executive Director dismissal. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.
