**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL**

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD February 5, 2019**

**A. Case No. L-CA-16-079

**2. Case No. L-CA-16-080

**3. Case No. L-CA-19-071
