III. APPROVAL OF MINUTES OF REGULAR MEETING HELD July 9, 2019

Chairman Gierut called for approval of the minutes of the July 9, 2019 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

**A. Case No. L-RC-18-021
Int'l Brotherhood of Teamsters, Local 700 and Chicago Transit Authority**

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**B. Case No. L-CA-15-042
Int'l Brotherhood of Teamsters, Local 700 and County of Cook and Sheriff of Cook County**

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**1. Case Nos. L-UC-19-001, 002, 003, 004

**2. Case No. L-RC-19-003
American Federation of State, County and Municipal Employees, Council 31 and City of Chicago**

General Counsel Kim called the case, noted that Administrative Law Judge Michelle N. Owen issued a Recommended Decision and Order with no exceptions filed and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CA-18-072
Chicago Journeymen Plumbers' Local 130, U.A. and City of Chicago (Water Department)**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to remand the case for further investigation. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.
