III. APPROVAL OF MINUTES OF REGULAR MEETING HELD APRIL 11, 2017

V. BOARD ACTIONS

1. **Case No. S-RC-17-022
International Brotherhood of Teamsters, Local 700/ Illinois State Tollway Authority**

General Counsel Kim called and presented the case. After discussion, Member Nelson moved to reject the RDO and remand to hearing. Member Snyder seconded the motion, and the Board passed it unanimously, by a voice vote.

2. **Case No. S-CA-16-137
Sharon White/State of Illinois, Department of Central Management Services (Human Services-Madden Mental Health Center)**

Associate General Counsel Hamburg-Gal called and presented the case. After discussion, Member Snyder moved to accept the Executive Director's dismissal with modifications. Member Nelson seconded the motion, and the Board passed it unanimously, by a voice vote.
